Mr. HOWES: Mr. President, I have a resolve I would like permis-

Mr. HOWES: Mr. President, I have a resolve I would like permission to put in. As to this resolve, I have put a great deal of time on it in the last few years, studying it, and I do not believe the resources of the state have been used up yet. I believe this resolve calls for the appointment of a committee. I believe, and have for some time, that

we might receive, perhaps twenty-five years from now, half or three-quarters of a million dollars or more revenue in the State of Maine than we are now receiving. I hope you will not turn this down until after you have heard it read. I believe there is some advantage to it.

The PRESIDENT: The Senator from Penobscot, Senator Howes, presents a resolve. By virtue of the terms of the joint order passed earlier in the session, it requires the unanimous consent of the members of the Senate for the introduction of this resolve.

Unanimous consent being given, Resolve to Create a Special Committee to Study Wild and Fur Bearing Animals (S. P. 383) was received and referred to the Committee on Inland Fisheries and Game.

Sent down for concurrence.

Mr. GOOD of Aroostook: Mr. President, I notice this morning before you on your desks a bag of potatoes which is a product of Aroostook County. We are proud of our industry in Maine and especially Aroostook County. Last year it turned in from the State over \$84,000.000. We have had several obstacles to encounter. About thirty years ago we met what is known as—

The PRESIDENT: The Chair inquires if the Senator intends to present an order?

Mr. GOOD: I do, Mr. President. The PRESIDENT: The Senator

may proceed.

Mr. GOOD: About thirty years ago we encountered this powdery scab and we overcame it and licked it. We have had several diseases that have come to us in one way or another and we have been able to cope with them. We have now in our vicinity a disease called netnecrosis, as some of you will know, and we think eventually we will overcome it. We have another disease known as ring-rot, or bacteria wilt, which is affecting a large number of the farms, and we feel if we are ever going to overcome these things we must be alert to the things that are bound to help us

Of course, you know that before the House today, before the Committee on Agriculture, will come a bill pertaining to a foundation seed program and some of the members of the Aroostook County delegation felt it would be a fine thing to send down some of the product we have grown up there and a group of men from Fort Fairfield have done just that. I present an order and move its passage.

the following new section: "Sec. 3. P. & S. L. 1939, c. 8, Art. XI, s 26 repealed and replaced. Section 26 of Article XI of chapter 8 of the private and special laws of 1939, as enacted by section 12 of chapter 86 of the private and special laws of 1943, is hereby repealed and replaced to read as fol-

lows: "'Sec. 26. Pension provisions for chief of police. The chief of police, after having served 25 years as such, or if permanently disabled while in the performance of some duty devolving upon him as a member of the department, shall be retired upon his petition; whereupon he shall be entitled to a pension equal to ½ of the pay which he received at the time the disability occurred or at the time his application was filed with the commispetitioning for retirement sion
