Mr. LEAVITT of Cumberland: Mr. President, I now move, in nonconcurrence with the House, that we substitute the bill for the re-

port.

This is a very insignificant bill. It has three words added to a bill which is already enacted. It adds to the people who shall have the right of reemployment in the State of Maine, along with men in military service, those who are members of the United States Merchant Marine.

I realize that with a unanimous report from the Judiciary Committee and with the action which the House has already taken, that this bill should be considered dead, but I hope this bill is not as dead as the thousands of merchant marine seamen who are now resting in

their graves at the bottom of the ocean, men who have died in the flames of tankers, men who have died on Murmansk, and who have been preys of the wolfpacks of the Atlantic Ocean.

The reason I understand the Committee on Judiciary did not see fit to pass this bill—the first reason was this legislation was in-opportune because the federal government had not yet passed legislation of a similar nature. I realize the Committee on Judiciary is busy and they have a great many bills before them and they must have overlooked H. R. 131, An Act to Provide Reemployment Rights for Persons who Leave their Positions to Serve in the Merchant Marine, and for other purposes. In that bill passed by Congress, dated June 23, 1943 there are these three provisions: First: "If such position was in the employ of the United States Government, its Territories or possessions, or the District of Columbia, such person shall be restored to such position or to a position of like seniority, status, and pay." The next section, "If such position was in the employer" such employee is also entitled to reemployment. The third provision is the one we are now interested in, "If such position was in the employ of any State or political subdivision therefo, it is hereby declared to be the sense of the Congress that such person shall be restored to such position or to a position or like seniority, status and pay."

seniority, status and pay."
Congress naturally will not dictate to the states and tell the states they must employ them, but it is the sense of this bill passed by Congress that the states should grant these reemployment rights to men of the merchant marine.

This bill, L. D. 503 simply puts the State of Maine in line with this piece of legislation which I understand the Committee on Judiciary did not know was in existence. I may be mistaken regarding that.

The second objection, as I understand it in talking with members of the Committee, if these men want status to be reemployed there is simply one thing they can do, they can join the armed forces of the United States — join the Navy or Army. In other words, this report of our Judiciary Committee denies the importance of the United

States Merchant Marine, which is the fourth branch of our national

defense.

Admiral Land in a recent speech stated that the Merchant Marine was the one industry in this country that absolutely mobilized itself and put itself at the disthe armed forces. posal of grant that industry and railroads and other forces of productive energy of the country also mobilized, but where railroads were making three and four hundred per cent more than they were before the war, and where private industry was making two to three hundred per cent at the end of 1943, the Merchant Marine was making one-third as much as they were in 1939 and doing three times as much work.

This industry has mobilized itself one hundred per cent. It is said, perhaps, these men that go into the Merchant Marine go in there Marine be might be talked have because they safer. Gentlemen, I have talked with thousands of men who have been in the Merchant Marine. My business is Merchant Marine. They are coming to my office at the rate of three or four or five a day and I am talking with them all the time. These men are not in the Merchant Marine because it is safer but because they know the Merchant Marine needs them. People say they have the choice of where they want to go, and they do. Most of the men are trying to get runs that go to Murmansk or they try to get runs that go across to Europe. They are not asking to get runs to South America where they will be safer, and they are not asking to stay along the coast. They are there because they realize the only way this war can be won and the only way it is won is by the contribution of the United States Merchant Marine.

Gentlemen, when we deny any one person the right of reemployment because of the fact he was so inconsiderate as to join the Merchant Marine, we are doing an injustice to that wonderful group of

Mr. DOW of Oxford: Mr. President and members of the Senate, as Chairman of the Judiciary Committee which reported this bill out "Ought Not to Pass" I think a few

remarks might be in order as to why we reported the bill that way. I want to say at the outset that it was not my intention, nor the intention of any member of that committee, to belittle the work of the Merchant Marine in this war. I think we all understand what a fine job they have done. I think we all understand that they have been practically indispensible. I do not believe we want to make any argument on this similar to Mr. Churchill's at the time he talked about "blood, toil, sweat and tears" Let us discuss this more or less from another view point.

At the hearing there were two proponents, Representative Carpenter, who introduced the bill, and Mr. Gordon of the Communist Mr. Party. I just mention this to show you the number of people present at the hearing, for another purpose later on. And against the bill there was one opponent, Representative Bell of Thomaston, I think. So I think possibly the report of the Committee might have been their own considered judgment rather than the persuasive arguments of those who appeared before the com-

mittee, due to lack of numbers.

Now as I said before, the Merchant Marine has done a wonderful job and they want to include them in this bill under consideration. Well, the ship-yard workers have done quite a job, too. The boys on the railroads have done quite a job. To be personal for just a minute, some of us fathers have given about all we have. We have done quite a job. There is no provision in this bill for us. We have bought many bonds. There are mothers who have sent their sons and they have gone all out. Then if you include the Merchant Marine in this bill let us do better than that; let us promise a job for everyone who contributes to this war effort. It seems to me that would be perfectly fair and eminently proper. That is my thought on the matter. Let us not single out a few people but let us include them all in this bill.

Our present law says that if any of these people in the armed services come back they shall get their jobs back. I am aware of the fact that Congress has passed this law which says that federal employees shall get their jobs back and they hope that state employees who have served in the Merchant Marine will. I didn't know about that until Senator Leavitt spoke about it. I want to be fair there. However, had I known it at the time the bill was discussed I don't think it would have affected my vote either way. In fact, I feel the same way now.

The fact that the federal government passed this law doesn't mean much to me because Congress has passed quite a few laws in the last few years that I wouldn't recommend to the state of Maine. I don't know how you feel about it but that is the way I feel. The question is, how far are we going to go? You probably know that members of the Merchant Marine do not have the exemption under the income tax law that members of the armed services have, and it looks to me as though in the broad sense if we are going to include these other people, whom we admit have done wonderful jobs, we ought to be consistent and go the whole way.

I understand that in the letter Senator Leavitt quoted from, Congress declared it was the understanding or the hope of Congress that the states would do the same. I say again, that doesn't mean much to me. Now, I don't want to be misunderstood on this matter. I do appreciate the work done by that group but I do not see any reason why they should be included in this bill unless you go the whole way and include all the others. I think that explains my position and possibly the position of the Committee on Judiciary. I hope that the motion of the Senator from Cumberland, Senator Leavitt, does not prevail.

Mr. LEAVITT: Mr. President, I would like to answer one argument of my friend, the Senator from Oxford, Senator Dow. The railroad employees and shipyard workers as yet have been spared the rigors of bombing and shell fire. The Merchant Marine, because of the fact they are taking the army and air forces to their destinations, have not been spared the bombing and shell fire.

I have a friend who was in the Merchant Marine three years. His ship laid off the beach at Anzio during the time the ship was bombed 39 times. When he returned to the United States he found people who apparently had the same feeling as the members of the Judiciary Committee, and didn't feel he was in the armed forces. This being bombed 39 times does not constitute being in the armed forces and doing anything to help the war, so he joined the Navy. While he was on board that ship there were three of the engineering force who stood watch four hours apiece. There were three oilers and there were three wipers and three men stood watch in that engine room. But in order to be a hero and get where he could wear a star and have people stand up and say, "Here comes the Navy" or "Here comes the Navy" in this particular case, it was the Navy—he joined the Navy and went on a ship exactly the same size as the Merchant Marine ship he was on before; and there were twelve officers, four in the hold at one time, four or five oilers and six or seven wipers, men of different ratings, electricians and all that. Even with the less pay that was being paid the Navy, it cost at least five times as much to run that ship under the Navy, and he has been there over a year, he hasn't seen one-fifth of the action he saw while lying off the beach of Anzio in a Merchant Marine ship. At the time of the Normandy invasion they took the Merchant Marine and had them in with the earliest arrivals, laying off there and taking the bombing and shelling.

bombing and shelling.

A boy came home the other day and he told me he lay there sixty days, off the Normandy beach, supplying the beachhead. The ship in front was blown entirely out of the water and every man was killed and the ship after his had over half the crew killed.

I say if you want to compare the men who get behind rivet guns in the shipyard with the men who are out there in life-rafts days and days, and sometimes never rescued, the boys who have gone down in burning oil, I think we are somewhere missing the humane point, and we are being pretty trivial when we say we will not give those boys the same right of employment we give the armed forces on the ground that we would also have to give fathers and railroad men and the other people the same status. If I am wrong, I am sorry.

When the vote is taken, Mr President, I ask for a division.

The PRESIDENT: The question before the Senate is on the motion of the Senator from Cumberland, Senator Leavitt, that the bill be substituted for the report. A division of the Senate has been asked.

A division of the Senate was had. Five having voted in the affirmative and twenty-four opposed, the motion to substitute did not prevail.

Thereupon, on motion by Mr. Dow of Oxford, the report of the committee, "Ought Not to Pass" was adopted in concurrence.

was adopted in concurrence.
On motion by Mr. Bishop of Sagadahoc the Senate voted to take

from the table, bill, An Act Relating to Town Reports (S. P. 375) (L. D. 969) tabled earlier in today's session by that Senator, pending passage to be enacted; and on further motion by the same Senator, the bill was passed to be enacted.
