## SENATE

# Friday, March 30, 1945.

The Senate was called to order by the President.

Prayer by the Rev. Herbert F. Aldrich of Augusta.

Journal of yesterday, read and approved.

'Provided, however, that the authority of the commission to regulate the opening and closing hours of each state store within the provisions of this chapter is qualified and restricted, as follows: In towns having a population of less than 10,000 inhabitants as recorded by the latest United States census, the legal voters may, by majority vote, at an annual or special town meeting, when acting upon an appro-priate article in the warrant, fix an hour at which legally established hour at which legany courses and state stores in such towns shall close on Saturdays. The closing hour so fixed shall not be earlier than 2:00 P. M. nor later than 10:00 P. M. When the hour has 10:00 P. M. been so established by the legal voters, it shall not be subject to change until the next annual town meeting.'"

On motion by Mr. Owen of Kennebec, the Senate voted to take from the table, Bill, An Act to Ex-tend Opportunities •for Secondary Education to Children Residing on the Island Classified as Unorganized Territory (S. P. 238) (L. D. 646) tabled by that Senator on March 15th pending enactment; and on further motion by the same Senator, the bill was passed to be enacted.

On motion by Mr. Owen of Kennebec, the Senate voted to take from the table, Bill, An Act Relat-ing to the Payment of Certain Obligations of the Recipients of Old Age Assistance and Aid to the Blind, under Certain Conditions (H. P 359) (L. D. 124) tabled by that

Senator on March 22nd pending enactment; and on further motion by the same Senator, the bill was passed to be enacted.

On motion by Mr. Owen of Kennebec, the Senate voted to take from the table, Bill, An Act Authorizing the Governor to Appoint Special Officers to Enforce Police Regulations Among the Indian Tribes of the State (H. P. 320) (L. D. 142) tabled by that Senator on March 28th pending enactment; and on further motion by the same Senator, the bill was passed to be enacted.

On motion by Mr. Owen of Kennebec, the Senate voted to take from the table, Resolve in Favor of the National Guard Association (H. P. 1087) (L. D. 777) tabled by that Senator on March 28th pending enactment; and on further motion by the same Senator, the Resolve was passed to be enacted.

On motion by Mr. Sterling of Somerset, the Senate voted to take from the table, Bill, An Act Relating to State Land in Augusta as a Public Park (H. P. 669) (L. D. 320) tabled by that Senator on March 29th pending passage to be engrossed; and on further motion by the same Senator, the bill was passed to be engrossed in concurrence.

On motion by Mr. Bishop of Sagadahoc, the Senate voted to take from the table, Bill, An Act Relating to Hunting in Merrymeeting Bay (H. P. 729) (L. D. 399) tabled by that Senator on March 27th pending passage to be engrossed; and on further motion by the same Senator, the bill was passed to be engrossed in concurrence.

On motion by Mr. Boucher of Androscoggin, the Senate voted to take from the table, Bill, An Act Relating to the Standard Non-Forfeiture Law and the Standard Valuation Law (H. P. 972) (L. D. 609) tabled by that Senator on March 23rd pending passage to be engrossed; and on further motion by the same Senator, the bill was passed to be engrossed in concurrence.

On motion by Mr. Bishop of Sagadahoc, the Senate voted to take from the table, Bill, An Act Relating to the State Police Retirement System (S. P. 76) (L. D. 71) tabled by that Senator on March 13th pending passage to be engrossed; and that Senator presented Senate Amendment "A" and moved its adoption:

"Senate Amendment 'A' to S. P. 76, L. D. 71, Bill, An Act Relating to the State Police Retirement System.

"Amend said bill by adding before the period at the end thereof the following: ', provided he has served at least 4 years as chief; otherwise he shall receive thereafter 1-2 of the pay per year that was paid to him as a member at the time he was appointed chief."

Thereupon, on motion by Mr. Noyes of Hancock, the bill and amendment were laid upon the table pending the motion to adopt Senate Amendment "A".

On motion by Mr. Good of Aroostook, the Senate voted to take from the table. Senate Report "Ought to Pass in New Draft" from the Committee on State Lands and Forest Preservation under new title on Resolve Authorizing the Forest Commissioner to Convey Certain Interest of the State in Lands in Oxford County to Fred J. Lovejoy, of West Bethel (S. P. 183) (L. D. 379) tabled by that Senator on March 29th pending acceptance of the report; and on further motion by the same Senator, the report of the committee was accepted and the bill laid upon the table for printing under the joint rules.
