Monday, April 9, 1945.

The Senate was called to order by the President.

Prayer by the Reverend Douglas H. Robbins of Augusta.

bec to adopt Senate Amendment A. Mr. HOPKINS: Mr. President, this bill came from the committee on a divided report and the in-formation which came to the hands of the committee indicated that protection in the State of Maine under their laws at the present time extends only to subnormal children. Opposition to the bill was voiced by representatives of industry. Probably there is no great amount of hazardous work being done in Maine by children. The amendment which the committee attached to the bill and on which the divided report was made was not entirely satisfactory. The reason for amending on the floor was to save time. The Senate has had before it the amendment which I submitted and I think it should be ready for action.

Thereupon, Senate Amendment A was adopted in non-concurrence, and the bill as so amended was tomorrow assigned for second read-

On motion by Mr. Dow of Oxford, the Senate voted to take from the table bill, An Act Relating to Salaries of Registers of Deeds in Oxford County (S. P. 262) (L. D. 625) tabled by that Senator on March 23 pending assignment for second reading.

Mr. DOW of Oxford: Mr. President and members of the Senate, there is another bill, a consolidated bill, for salaries which includes these same officials and I have held this on the table until that bill got along far enough to be signed by the Governor, if it was to be signed, and Legislative Document 886 covering these same people has been signed by the Governor and consequently I move that this bill be indefinitely postponed.

The motion prevailed, and the bill was indefinitely postponed. Sent down for concurrence.
