In convention of the memberselect of the Ninety-third Legisla-

ture

This day being the day designated by the Constitution of the State for the meeting of the Ninety-third Legislature, the members-elect of the House of Representatives assembled in the Hall of the House of Representatives at ten o'clock A. M. and were called to order by Harvey R. Pease, Clerk of the House of 1945

Prayer was then offered by the Rev. Mr. Riedel of Augusta.

A communication was received from the Secretary of State transmitting a certified roll of the Representatives-elect of the Ninety-third Legislature, which was read by Mr. Pease.

On motion by Mr. Mills of Farmington, the communication was or-

dered placed on file.

A certified roll of Representativeselect was then called by the Clerk of the Ninety-second Legislature. The elected membership of the House being 151, 142 members-elect having answered to their names, a quorum was found to be present.

Those who were absent were: Messrs. Dorsey of Fort Fairfield, Burgess of Limestone, Violette of Van Buren, Anderson of New Sweden, Cousins of Fort Kent, Martin of Eagle Lake, Pratt of Windham, Payson of Union, and Lackee of Addison.

On motion by Mr. Mills of Farmington, that gentleman and Messrs. House of Lincoln, Sweetser of Cumberland, Fuller of Buckfield, Kent of Randolph, Turner of Leeds, and Jalbert of Lewiston, were appointed a committee to wait upon the Governor and inform him that a quorum of the members of the House of Representatives-elect had assembled in the Representatives' Hall and request his attendance to administer to them the oaths required by the Constitution to qualify them to enter upon the discharge of their official duties.

Mr. Mills subsequently reported that the committee had discharged the duty assigned it, and the Governor was pleased to say that he would forthwith attend upon the Representatives-elect for the pur-

pose of administering to them the oaths required by the Constitution.

The report of the committee was

accepted.

Thereupon, the Governor, attended by his Council, and escorted by the Honorable Harold I. Goss, Secretary of State, entered the Hall amid the applause of the House, the members rising.

Governor Hildreth then address-

ed the House as follows:

GOVERNOR HILDRETH: Members of the Ninety-third Legislature: Tomorrow I shall have occasion to address you somewhat formally on the problems that will face us during this session. Today my duty is simply to administer your oaths of office. May I, however, take advantage of this opportunity today to wish you all a happy New Year and to welcome you to Augusta and to our Capitol. (Applause)

The Governor then administered

The Governor then administered to the members-elect, and they subscribed the oaths required by the Constitution to qualify them to discharge their official duties

On motion by Mr. Bowker of Portland, that gentleman and Messrs. Atherton of Bangor, Bell of Thomaston, Stearns of Hiram, Snow of Auburn, Woodworth of Fairfield, and Corson of Hodgdon, were appointed a committee to receive, sort and count votes for Speaker of the House.

Subsequently Mr. Bowker, for the committee, reported that the committee had attended to its duty and that the whole number of votes cast was 142; necessary for a choice, 72. John F. Ward, of Millinocket, had 124. Louis Jalbert of Lewiston, had 18.

Thereupon, on motion by Mr. Jalbert, Hon. John F. Ward was declared unanimously elected as Speaker of the House of Representatives of the Ninety-third Legislature.

Speaker Ward was then escorted to the rostrum by the gentleman from Lewiston, Mr. Jalbert, where he assumed the Chair, amid the applause of the House, the members rising.

Speaker WARD: Ladies and Gentlemen of the Ninety-third Legislature: Mere words are inadequate to express my gratitude to you this morning for the high honor you have conferred upon me and for

the confidence you have reposed in me.

In accepting this office, I am not unmindful of the grave responsibilities which accompany it, nor of the outstanding men who have pre-

ceded me in it.

Undoubtedly I shall make mistakes as we proceed with the session, and, when I do, I assure you now that they will be honest mistakes, because it will be my constant aim and high purpose to be the servant of this House and to preside over your deliberations with the utmost impartiality toward all at all times; and if, perchance, the members down front occasionally lose sight of the Speaker behind this rostrum, because of his height, he will endeavor to remind them of his pres-

we are opening the first regular session of this post-war era, and advance information indicates that it will not only be busy but also important to the citizens of Maine.

I suggest to you on this opening morning that many points of procedure will arise as we proceed with the session, and a large percentage of them may well be settled in advance by consultation between the parties involved and the Speaker. The Speaker's office will be open to you at all times for that purpose and for any other purpose which pertains to the business at hand.

By tradition, this being the first day of the New Year, it is a day of the New Year.

I feel confident, therefore, that one hundred and fifty-one individual resolutions have been made that we will each approach the problems which lie ahead fearlessly and with honesty and with courage, and that, by the application of a generous portion of good common sense, we will bring this first regular session of the Ninety-third Legislature to a suc-cessful conclusion. M. this afternoon for the purpose of electing a Secretary of State, Treasurer of State, Attorney General, Commissioner of Agriculture, and the seven Executive Councilors.

On motion by Mr. Mills of Farmington, the House voted to concur with the Senate in the proposition for a Joint Convention, and the Clerk was charged with and con-veyed a message to the Senate, in-forming that body that the House concurred in the proposition for a

Joint Convention.

The Clerk subsequently reported that he had discharged the duty assigned him.

ORDERED, that Ruel C. Hanks of Augusta, be the Official Reporter of the House for the present session; and that he be authorized to procure the services of a typist and proof-reader during the present session of the preparation and completion of the Legislative Record.

ORDERED, that the Bureau of Purchases be directed to furnish on requisition of the Clerk of the House, such stationery, office supplies and equipment as may be needed to carry on the business of the House.

The SPEAKER: The Chair recog-

Mr. MILLS: Mr. Speaker, I ask that by unanimous consent, the order of business as provided in the rules just adopted be dispensed with and that the House proceed under Orders of the Day.

"6. One monitor shall be appointed by the Speaker for each division of the House, whose duty shall be to see to the observance of the rules of the House, and on demand of the Speaker, to return the number of votes and members in his division."

"7. If any member shall transgress any of the rules of the House, and persist therein, after being notified thereof by any monitor, it shall be the duty of such monitor to give information thereof to the House.

The Chair will appoint as monitor of the first division, the gentleman from Portland, Mr. Bowker; of the second division, the gentleman from Corinth, Mr. Elliott; of the third division, the gentleman from Strong, Mr. Jennings; of the fourth division, the gentleman from Rockland, Mr. Sleeper.

On motion by Mr. Mills of Farmington, out of order and under suspension of the rules, it was

ORDERED, that the members of the House proceed with the drawing of seats; and that the usual monitors' seats be assigned to the monitors appointed by the Speaker; that a choice of seats be granted to Floor Leaders and Assistant Floor $_{
m the}$ majority Leaders of minority parties; that a choice of seats be granted to the lady members of the House and other members with physical disabilities.

The SPEAKER: The Chair would like to call to the attention of the members of the House the fact that in addition to giving the Floor Leaders and the Assistant Floor Leaders a choice of seats, that any member who is under physical disabilities which seem to him to entitle him to a particular seat or location in the House, is entitled to come down front and select a seat which will best suit his needs. Now the members should not be bashful in that regard but should take advantage of that offer and come down and get a seat, or if it is hard for any member to move in several seats, and that member wishes to be on the end, because he cannot get by several other members, he may come down and select his seat. This is not an invitation for any members who are one hundred percent perfect to come down and select their seats, but if any members do have physical incapacities, they should avail themselves of this opportunity at this time.

Thereupon, the House proceeded with the drawing of seats.

The SPEAKER: The Chair at this time wishes to call to the attention of the members Rule 10, which reads as follows:

"The seat which a member draws at the commencement of the session shall be his during the session, unless he shall have leave of the Speaker to change it, and no other person shall be permitted to occupy a member's seat at any time during a session of the House."

The Speaker grants permission to the members to trade seats from now until tomorrow noon. a member has drawn a seat, and would like to swap with some other member, he may do so any time between now and tomorrow at twelve o'clock. After that time, the members will then sign the cards which will be distributed, and each member will then receive keys for their locker and for their desk. The members will sign their cards and present them to the document room, to receive their keys.
