Wednesday, January 1, 1947

Pursuant to the provisions of the Constitution and the laws of the State of Maine, the Senators-elect to the Ninety-third Legislature convened in the Senate Chamber and were called to order by Chester T. Winslow, Secretary of the Senate of the Ninety-second Legislature.

33 Senators-elect having answered to the roll-call, the Secretary declared that a quorum was present.

On motion by Mr. Dunbar of Washington that Senator-elect was charged with a message to the Governor and Council informing them that a quorum of the Senators-elect was present in the Senate Chamber ready to take and subscribe to the oaths of office required by the Constitution to qualify them to enter upon the discharge of their official

Subsequently Mr. Dunbar reported that he had delivered the message with which he was charged and the Governor was pleased to reply that

he would attend upon the Senatorselect forthwith for the purpose of administering to them the oaths of office required by the Constitution.

Thereupon, the Governor, Honorable Horace Hildreth, attended by the Executive Council, came in, before whom the Senators-elect took and subscribed the oaths of office required by the Constitution.

The Governor and Council then

withdrew.

On motion by Mr. Batchelder of York, the Secretary appointed the following committee to receive, sort and count ballots for the office of President of the Senate: Senators: BATCHELDER of York

The motion prevailed and Mr. Varney was escorted to the Chair by Mr. Cleaves of Cumberland. The PRESIDENT: Members

This was done, and Chester T. Winslow of Raymond was declared duly elected Secretary of the Senate for the political years 1947 and 1948.

At the request of the President, for the

Mr. Morrill of Cumberland escorted the Secretary-elect to the Council Chamber for the purpose of taking and subscribing the necessary oaths of office to qualify him to enter upon the discharge of his official

duties.

Subsequently Mr. Morrill reported to the Senate that he had attended to the duty assigned to him, and that Chester T. Winslow had, before the Governor and Council, taken and subscribed the oaths of office required to qualify him for the discharge of the duties of the Secretary of the Senate.

On motion by Mr. Welch of Aroostook Mr. Willey of Hancock was authorized to cast one ballot on the part of the Senate in favor of Waldo H. Clark for Assistant Secretary of the Senate. This was done, and Waldo H. Clark of Jefferson was declared duly elected Assistant Secretary of the Senate for the political years 1947 and 1948.

Mr. Clark subsequently appeared before Dedimus Justice, and took and subscribed the oaths of office.

On motion by Mr. Clear Cumberland, Mr. Smith of Cleaves of Knox was authorized to cast one ballot on the part of the Senate in favor of Leland S. King for Sergeant-at-Arms of the Senate.

This was done, and Mr. King declared duly elected Sergeant-at-Arms of the Senate for the political

years 1947 and 1948.
