SENATE

Thursday, January 16, 1947.

The Senate was called to order by the President.

Prayer by the Reverend Gordon Washburn of Hallowell.

Journal of yesterday read and approved.

ORDERED the House concurring, that when the Senate and House adjourn, they adjourn to meet on Tuesday, January 21st, 1947, at 4:30 o'clock in the afternoon. (S. P. 65)
