#### SENATE

Wednesday, April 2, 1947.

The Senate was called to order by the President.

Rev. Cymbrid Prayer by the Hughes of Augusta.

Journal of yesterday read and approved.

#### Referred to Committees

#### Orders of the Day

On motion by Miss Clough of Penobscot, the Senate voted to take from the table Senate Report from the Committee on Judiciary on (S. P. 126) (L.D. 289) bill, An Act Relating to Discriminating Against Persons. Majority Report "Ought Not to Pass", Minority Report "Ought to Pass in New Draft", tabled by that Senator on March 25 pending adoption of either report; and on further motion by the same Senator, the Majority Report "Ought Not to Pass" was adopted. Sent down for concurrence.

On motion by Mr. Leavitt of Cumberland, the Senate voted to

take from the table bill, An Act to Increase State Aid to Towns for the Support of Schools to Establish Minimum Salaries for Teachers (S. P. 478) (L. D. 1336) tabled by that Senator on March 27 pending assignment for second reading, and that Senator yielded to the Senator from Sagadahoc, Senator Sagadahoc, tor from Senator Bishop.

The Senator from Sagadahoc. Senator Bishop presented Senate Amendment and moved

in subsection II in that part designated Sec. 201, the 10th, 11th, 12th and 13th lines and inserting in

place thereof the following: approved by the commissioner, a budgetary balance after deducting subsidy as above mentioned, which shall provide an amount sufficient to allocate to each municipality, units, as hereinafter determined, which shall be not less than \$100

each, based on the effort made''
Mr. BISHOP of Sagadahoc: Mr.
President this amendment simply clarifies the grammatical construction of that section. It doesn't change the meaning of the bill any except to make it a little more clear.

Thereupon, Senate Amendment A

was adopted.

On motion by Mr. Leavitt of Cumberland, the rules were sus-pended and the bill was given a second reading and passed to be engrossed as amended. Sent down for concurrence.

On motion by Mr. Boucher of Androscoggin, the Senate voted to take from the table Senate Report "Ought Not to Pass" from the Committee on Lord Services. mittee on Legal Affairs on bill, An Act Relating to the Salaries of the Police Department of the City of Lewiston (S. P. 234) (L. D. 976) tabled by that Senator on March 7 pending adoption of the report; and on further motion by the same Senator, the "Ought Not to Pass" report of the committee was adopted. On motion by Mr. Boucher of Androscoggin, the Senate voted to take from the table Senate Report "Ought Not to Pass" from the Committee on Legal Affairs on bill. An Act Relating to Salaries of Police Officers of the City of Lewiston (S. P. 320) (L. D. 872) tabled by that Senator on March 7 pending adoption of the report; and on further motion by the same Senator, the "Ought Not to Pass" report of the committee was adopted.

#### **Emergency Measure**

From the House, out of order and under suspension of the rules:

"An Act Amending the Charter of the City of Lewiston." (S. P. 475)

Which Bill being an Emergency Measure, and having received the affirmative vote of 28 Members of the Senate, and none opposed, was passed to be enacted.

On motion by Mr. Williams of Penobscot, the Senate voted to take from the table bill, An Act Relating to Bank Accounts and Deposits of Town Treasurers (H. P. 273) (L. D. 185) tabled by that Senator on March 6 pending passage to be

enacted.
Mr. WILLIAMS of Penobscot:
Mr. President and Senators, the reason for tabling this bill was that I felt that in its present form it might be a little hardship on some town officials or town treasurers in the matter of depositing because there are seasons of the year when, as you all know, in the smaller towns of the state very little money is taken in. And under this bill I could conceive where the town treasurer would have to bother to deposit maybe a matter of \$1.98 or something like that a couple of times a month.

It may be a minor matter but I have prepared an amendment which would do away with that inconvenience. The amendment reads:

"The provisions of the preceding sentence shall not apply to cash balances until such balances shall exceed \$100", which would appear to me more reasonable than that they should have to deposit twice a month any amount they might have, and I think this amendment will take care of the smaller towns and the bill still do away with the abuses that there could be under the present law that town treasurers could hold funds for some time until they were deposited. I offer Senate Amendment A and move its adoption.

Thereupon, on motion by Mr. Williams of Penobscot, the rules were suspended and the Senate voted to reconsider its former action whereby this bill was passed to be engrossed. That Senator presented Senate Amendment A and moved

its adoption.

The Secretary read the amendment:

ment:

"Senate Amendment A to (H. P. 273) (L. D. 185) bill, An Act Relating to Bank Accounts and Deposits of Town Treasurers. Amend said bill by adding at the end thereof the following underlined sentence: "The provisions of the preceding sentence shall not apply to cash balances until such balances shall exceed \$100."

Senate Amendment A was adopted and the bill as so amended was passed to be engrossed in non-concurrence.

Sent down for concurrence.
