SENATE

Thursday, April 17, 1947. The Senate was called to order by the President.

Prayer by the Reverend Wesley U. Riedel of Augusta. Journal of yesterday read and

On motion by Mr. Williams of Penobscot, it was

On motion by Mr. Morrill of Cumberland, the Senate voted to take from the table House Report "Ought to Pass" from the Committee on Sea and Shore Fisheries on bill, An Act Providing for Restoration and Development of Shellfish Resources, (H. P. 1453) (L. D. 1050) tabled by that Senator on April 8 pending consideration of the report; and on further motion by the same Senator, the report was adopted and the bill was given its first reading.

That Senator presented Senate Amendment A and moved its adoption.

Mr. MORRILL of Cumberland: Mr. President, the explanation of that amendment is quite a long one, and in consideration of the Secretary of the Senate, I will explain it. The original bill has to do with setting up shellfish license fees, and the license fees to go with canning clams. Within it, it embodies the arm of the Department of Agriculture in the enforcement of the sanitary conditions under which clams are shucked and packed. There was some wording in there that we hadn't changed to make it conform with the wording now used in the forms already in use by the Department of Agriculture.

The second point was a correction so that this bill will conform with section 91 of another bill which is coming in which will revise the whole of Chapter 34 of the laws regarding Sea and Shore Fisheries.

I assure you it is a technical and functional amendment.

Thereupon, the amendment was adopted without reading, and the bill as amended by Senate Amendment A was tomorrow assigned for second reading.

On motion by Mr. Barnes of Aroostook, the Senate voted to take from the table bill, An Act Relating to Eligibility of Certain Clubs for Liquor Licenses (S. P. 476) (L. D. 1329) tabled by that Senator on April 16 pending passage to be enacted; and on further motion by the same Senator, the bill was passed to be enacted.

Mr. Bishop of Sagadahoc was granted unanimous consent to address the Senate.

Mr. BISHOP of Sagadahoc: Mr. President and members of the Senate, this may be an unusual request, but this afternoon just before the House convenes, arrangements have been made to give a little time to a young boy, a young fellow in the State who has just competed in an oratorical contest sponsored by the American Legion, who won the State honors. It is said he did a remarkable job. His subject was The Constitution of the United States. It was compiled by his own efforts. It seems to be a remarkable approach to the subject.

He went to the regional contest in New Hampshire and was eliminated with a very close second place, but he has done such a fine job that it seems we ought to recognize him in this state as having accomplished quite a feat. He will

speak this afternoon about four o'clock. It will be informal. We hope the members of the Senate will join at the time with the members of the House and form a large and receptive audience to hear him give this address. It takes only about 10 minutes but it seems we are so concerned about the po-sition that Maine holds in the edu-cational field that one who could do as good a job as this should have some recognition.

I hope the members of the Sen-ate will find it convenient to join with the House this afternoon and hear this address.

Mr. Welch of Aroostook was

granted unanimous consent to address the Senate.

Mr. WELCH of Aroostook: Mr. President and Members of the Senate, I just want to make a few re-marks in regard to the potatoes which you find once again placed on your desks this morning.

These potatoes were furnished by Elwood Noyes of Limestone and presented through the efforts of Representative Burgess from the same town. I hope you will enjoy them.
