Orders of the Day

Civil Defense and Public Safety Agency, Aid to Charitable Institutions, fourteen in number; Boxing Commission. On January 30th, yesterday, Forestry, Park Commission, Search for Lost Persons, Adjutant General, Military Defense Commission and the Secretary of State.

We have not held any executive sessions on any of the department reports as yet, so we are unable to make any further report on this line.

We had in mind to present to you a suggestion from the Liquor Commission, but I understand there is a bill already drafted to be presented to this Legislature on this matter, and it would, of course, be unwise to discuss any bill before it is presented. That is all of the report, Mr. Speaker.
