The SPEAKER: Under Orders of the Day, the Chair lays before the House the first tabled and today assigned matter, Bill, "An Act relating to the Taxation of Telephone and Telegraph Companies and Electric Light and Power Companies" (S. P. 261) (L. D. 559) tabled on February 14 by the gentleman from Cape Elizabeth, Mr. Chase, pending reference in concurrence; and the Chair recognizes that gentleman.

Mr. CHASE: Mr. Speaker. Constitution provides that any bill for raising of revenue must origi-nate in the House of Representatives. As the members may see, if they will consult L. D. 559 and look at the first line on the top of page 2, this is such a bill for raising of revenue. It did originate in the Senate where it was introduced by a Senator by request. The bill is, therefore, constitutionally defective. It represents the thought of a worthy citizen who wants to make his contribution, as he believes, toward the solution of the taxation problem.

It is too late now for a new bill to be introduced by the regular procedure. The only method which I know by which this defect can be corrected is through the introduction of this bill by unanimous consent. I am, therefore, Mr. Speaker, in order to try to assist in correcting this technical but deadly defect, asking for unanimous consent that this bill be introduced in the House and I am willing to put my name on it as introducing it by request if there is no other member who would like to have his name put on it.

The SPEAKER: The Chair will inform the gentleman from Cape Elizabeth, Mr. Chase, that the question before the House is reference of this particular bill.

Does the gentleman wish to indefinitely postpone it and, at a later date, present the new bill and request unanimous consent for its introduction?

Mr. CHASE: I will be glad to conform to any procedure which

the Speaker may prefer. Perhaps I should have raised a point of crder but the bill is obviously defective and if, in the opinion of the Chair, that is the best method of handling it, I will move that it be indefinitely postponed.

The SPEAKER: The gentleman

The SPEAKER: The gentleman from Cape Elizabeth, Mr. Chase, moves that Bill "An Act relating to the Taxation of Telephone and Telegraph Companies and Electric Light and Power Companies" (S. P. 261) (L. D. 559) be indefinitely postponed. Is this the pleasure of the House?

The motion prevailed and the bill was indefinitely postponed in non-concurrence and sent up for concurrence.

The SPEAKER: The Chair recognizes the gentleman from Calais, Mr. Hall.

Mr. HALL: Mr. Speaker Members of the House: Yesterday, by error of one type or another, Item 48 on yesterday's calendar, "Resolve Creating a Legislative Interim Committee to Implement the Engineering and Economic Study of Maine Highway Needs" (H. P. 1115) was referred to the Committee on Judiciary. Having talked with the Committee on Reference of Bills, I find it was intended that this being a highway bill it should be referred to the Committee on Highways. Therefore, I would like to ask the House to reconsider its action of yesterday whereby it referred H. P. 1115 to the Committee on Judiciary.

The SPEAKER: The gentleman from Calais, Mr. Hall, moves that the House reconsider its action of yesterday whereby it referred Resolve Creating a Legislative Interim Committee to Implement the Engineering and Economic Study of Maine Highway Needs (H. P. 1115) to the Committee on Judiciary.

Is this the pleasure of the House? The motion prevailed; and on further motion of the same gentleman the Resolve was referred to the Committee on Highways and sent up for concurrence.

On motion of Mr. Jamieson of Presque Isle, the House voted to take from the table the 9th tabled and unassigned matter, Bill "An Act relating to Motor Vehicles Parking in Dangerous Places" (H. P. 95) (L. D. 40) tabled by that gentleman on February 14th pending adoption of House Amendment "A."

On further motion of the same gentleman, House Amendment "A" was adopted, and the Bill, having already had its three several readings, was passed to be engrossed as amended and sent to the Senate.

The SPEAKER: The Chair at this time would like to call the attention of the members to Rule 19 of the Joint Rules. The reason that the Chair calls the attention of the members to this rule at the moment is due to the fact that there are a number of House Chairmen present, I hope, and all of the House members of the Committee on Appropriations are present, and it would be difficult to contact each and every one of you separately.

Now Rule 19 of the Joint Rules on Page 58 provides: "The several clerks of the committees to which are referred bills, orders or resolves involving the appropriation or expenditure of money shall forthwith upon receipt of such bills transmit a copy thereof carrying endorsement of reference, to the Committee on Appropriations and Financial Affairs. No bill shall be in order for advertising for hearing or any other procedure until such copy is so transmitted." means exactly what it says to you members of the committees: A bill involving money, a copy of it must be sent to the Appropriations Com-"The appropriations committee shall issue a printed report and tabulation of such bills weekly."

The Chair hopes that the Appropriations Committee will proceed to get out this report. The Chair knows they have been very busy, but some of the members have been inquiring, and the Chair thought it would be well to call this matter to the attention of the members this morning while they are all present.

If there is no further business, the Clerk will read the notices.
