#### Orders of the Day

On motion by Mr. Wight of Penobscot the Senate voted to take from the table Joint Order from the House directing chairmen of the several Joint Standing Committees to have prepared before 2 P. M. of each Tuesday copies of a list of all bills and resolves which have been assigned for public hearings the following week, etc. (H. P. 478), tabled by that Senator earlier in today's session pending passage in concurrence; and that Senator

yielded to the Senator from Penobscot, Senator Haskell.

Mr. HASKELL of Penobscot Mr. President and members of the Senate, I shall speak to a motion to indefinitely postpone the order. My reasons for thinking that this order should not have passage are tempered by my desire to show courtesy to the House and also a desire to show courtesy to the weekly papers, but the order does in effect tell the Senate chairmen that within two and one half hours from now, for example, each one of you must make up your legislative program of next week. It does not seem to me that to do this would be efficient or orderly operation of this legislature. I realize that there will be occasions when many chairmen can design their legislative program for succeeding weeks on Tuesday morning of the preceding week but by and large I do not believe that the best interests of the members of the legislature or the best interests of the people of the State of Maine would be served by setting up this mandatory provision that the committee chairmen shall prepare these programs and send them to the newspapers as early in the legis-lative week as this. There certainly is nothing to prevent a committee chairman from designing his committee hearings a week, or two or three weeks, ahead but to tell all of us that we must do so and thus close the door to any redesigning of the legislative program for the next week does not seem to me to be the thing for us to do. And thus, Mr. President and members of the Senate, my motion would be that the order be indefinitely postponed.

Mr. REID of Kennebec: Mr. President and members of the Senate, I hesitate to speak in opposition to the motion but I must say that I have extended the courtesy to an owner of a weekly newspaper to discuss this matter with her after the session today and therefore I hesitate to favor the motion and would like to move that the order be laid upon the table.

The PRESIDENT: The Senator from Kennebec, Senator Reid, moves that the order be laid upon the table pending the motion of the Senator from Penobscot, Sena-

tor Haskell, that the order be indefinitely postponed. Is it the pleasure of the Senate that the order be laid upon the table pending the motion of the Senator from Penobscot, Senator Haskell that the order be indefinitely postponed?

The motion to table prevailed.

Mr. Tabb of Kennebec was granted unanimous consent to address the Senate.

Mr. TABB of Kennebec: Mr. President and members of the Senate, about a week or ten days ago you had on your desks the recommendations of the Research Committee on County Government. At that time I asked for unanimous consent to address you and drew to your attention a paragraph in that report that stated that this was not the unanimous report of the committee. I also asked you not to make up your minds in any way until you had seen the report made by Professor Dow. And you may remember I said that there were two members who did not agree with the whole report and that we were going to be allowed, instead of writing a minority report, to have the privilege to express our feelings on the floor. My colleague in the House will undoubtedly do the same thing so now I am ready to tell you for my part, as a member of that committee, why I am opposed to the Dow report.

First I will say that I am not wholly opposed to it. I do agree with some things that it says in regard to jails because I know that our subcommittee investigated these jails and brought back practically the same report that is in here. There are other minor things that I am willing to go along with but the main part of the program that I am not willing to go along with is that in my opinion this report is the beginning of centralization of goovernment in our state.

The principal thing that this report contains, and this comes under Summary of Recommendations, is that judges of probate shall be appointed, as they are at the present time the only elected judges in Maine. I can't see for the life of me why that privilege should be taken away from the people. I believe we have had some very fine judges of probate. I know our own Judge in Kennebec County is a great credit and I don't believe any Chief Justice—I have no grudge against them in any way, shape or manner—but I don't believe that they could make any finer selection than we now have in Kennebec County and I feel that is generally the same feeling throughout the state.

It then goes on to say that clerks of court and registers of probate should be appointed by the Court, and then he says that county attorneys should be replaced by appointed district attorneys. That is another thing they want to take away from the rights of the people and the Attorney General would appoint the county attorneys.

I will admit perhaps we haven't always the best caliber or perhaps the highest standard in the legal profession for our county attorneys. I do not question in my own mind that some of the county attorneys have not lived up to what they should do as county attorneys and haven't kept their oath. Nevertheless I have been around the statehouse quite a number of years. I have seen a good many Attorney Generals in office and I don't think their judgment in selecting assistant attorney generals has been any criterion to go by that we should give the Attorney General the right to appoint these county attornevs.

"Municipal and trial justice courts to be replaced by district court." I quite agree that trial justices should be abolished after reading this report.

Then he goes on to say that shercommissioners iffs, county and county treasurers should be abolished. In fact he wants to put the sheriffs department in the hands of the state police. Now you realize that we have heard complaints from the state police that they have too much work to do now and cannot do it all unless they have more police officers and I don't believe that those boys, riding around in cars as we all see them, would care to take over the sheriff's duties and I don't believe they would do any better than the sheriffs. The last part, as I said, on jails and so forth I practically agree with.

Now while you are reading this report I want you to bear in mind that this is America. There isn't a man in this Senate but who, if he were asked today what form of government he wanted, would say naturally, the one we have. Democracy!

There isn't anybody who wants centralization of government. You know that the government was made for the people, and never the people for the government. You know as well as I do that ever since the founding of this country we have tried to bring about that political freedom, economic and religious freedom. That is the one thing we have strived for. And in this report he wants to centralize government. I think you will all agree with me that there is less freedom in the world today than ever before and even here in America before the signing of the Declaration of Independence, we had more freedom than we have Still this report wants to now. centralize government. What we have in this country is a government that will keep the aggressor out and also help us to be protected from the enemies within, and centralized government is nothing more than an enemy within.

In another part of this report he says that fewer elective offices mean less of a burden on the voter. Imagine that. Fewer elective offices mean less of a burden on the voter! In the inaugural address of the Governor he said that we want a government that is closer to the people. Surely this report does not bring it closer to the people. They want to put this government under the control of just a few and take the rights away from the people.

Mr. Dow, on the first page of the report says that he accepts the full responsibility for the facts and opinions found in this report. At the research hearing he brought in a stack of books about that high and I questioned him about where he was getting his report and he informed me that it was from twenty-five years of teaching. I also asked him if he did not get some of it out of those books that he had there which were books written by a bunch of bureaucrats that believe in world government. That is what we have in this report and if that is what they teach at the University of Maine they had better teach them Democracy instead of centralization of government.

I hope, Mr. President and members of the Senate, that you will think seriously on any bills that ever come in on this report designed to take away the rights of the people of this state because I am warning you that the Professor belongs to that crowd that believes in world government.
