Orders of the Day

On motion by Mr. Reid of Kennebec, the Senate voted to take from the table House Order re Advertising in Weekly Newspapers of the State, Public Hearings on Bills and Resolves (H. P. 478) tabled by that Senator on February 10 pending motion by the Senator from Penobscot, Senator Haskell, that the Order be indefinitely postponed.

Mr. REID of Kennebec: Mr. President, I expect that when the vote is taken you will vote in favor of

the motion to indefinitely postpone this House Order. If it is indefinitely postponed I intend thereafter to introduce an Order out of order, with reference to the same subject matter, for this reason.

It appears that there are quite a number of weekly newspapers which are seriously interested in being able to a certain degree to publish notices of hearings. The difficulty has been explained why we cannot operate under this order which was tabled. Some of the larger committees certainly cannot predict two weeks in advance what bills they are going to have hearings on, and so the following program has been tentatively worked out and will be included in the order which I will introduce. Taking six committees - I have talked with the chairmen of five of the six, with the exception of the Senator from Penobscot, Senator Wight, the six committees being the Committees on Agriculture, Education, Inland Fisheries and Game, Sea and Shore Fisheries, Taxation and Towns and Counties. Those committees were selected on the theory that public hearings before them would be more likely to interest those people who read only the weeklies and do not bother with the dailies.

The proposition is this, and at no expense to the state. If the clerks of those six committees will make every reasonable effort to supply information with respect to those bills to be heard the following week, to just one man in the state house, Floyd Newt, he will see to it that all these weeklies are telephoned, by a chain telephone system which they will work out. The information will be phoned to the interested weekly newspapers who will then be able to go to press with that information. They will be perfectly satisfied with that, that these committees are the ones which will most interest the readers of the weeklies. I wish to apologize to the Senator from Penobscot, Senator Wight, in not being able to ask his consent, but the other five chairmen think that this is a workable idea.

As I said, there will be no cost to the state. The order will read that the information be delivered to the Clerk of the House of Representatives, but actually the information will be picked up by Floyd Newt and he will carry on from there.

The PRESIDENT: The question before the Senate is on the motion of the Senator from Penobscot, Senator Haskell, that the Order be indefinitely postponed. Is this the pleasure of the Senate?

The motion prevailed and House Paper 478 was indefinitely postponed in non-concurrence.

Order (Out of Order)

Mr. Reid presented the following order, out of order and under suspension of the rules, and moved its passage:

ORDERED, the House concurring, that the chairmen of the Committees on Agriculture, Education, Inland Fisheries and Game, Sea and Taxation Shore Fisheries. Towns and Counties, be requested to make every reasonable effort to have prepared, not later than 2 P. M. on each Wednesday, such bills as they will hear in public hearings during the following week. The listings so prepared shall be given to the Clerk of the House for delivery to such weekly newspapers as may desire to use the information as a public service to their subscribers.

Mr. COLLINS of Aroostook: Mr. President, I would like to ask the Senator from Kennebec a question. If this plan is followed, whether or not the notices will also be given to the daily papers on these same hearings. If they are, why of course, it does mean additional printing expense to the state on the weekly papers. While I have not too much objection to that, I wonder whether we would get complete enough coverage through the weekly papers to satisfy the entire state.

Mr. REID of Kennebec: Mr. President, in answer to the Senator's question, this order contemplates no change whatsoever with the existing routine, with respect to the daily papers. It is entirely separate from them. I assume that the clerks will operate just as they have been operating in the past. This is simply a service for the weeklies. There is no commitment

on the part of the legislature or on the part of the committees to give the full and complete story, but just that they use every reasonable effort.

In other words, if a clerk of one of these committees knows by two o'clock Wednesday that certain bills are to have public hearing, he will provide that information to It may be that the Flovd Newt. next day the committee will decide to have further hearings for that week, and these listings will go as usual to the dailies but will be too late for the weekly newspapers. They are perfectly satisfied with this arrangement. Does that answer the Senator's question?

Mr. COLLINS: Mr. President, I am very well satisfied with the explanation but of course it does involve the actual printing in the papers. That will be an additional cost to the state.

Mr. REID: Mr. President, the several clerks of these committees will give the information orally or by printed lists, to Floyd Newt. He will telephone the weekly papers who are interested. They will print what he gives them, at their own expense, and there will be no telephone expense to the state. They will accept that expense.

Mr. SILSBY of Hancock: Mr. President, I would like to inquire of the Senator from Kennebec, Senator Reid, if the notices that are to be printed in the weekly papers will appear on the Wednesday following their receipt of the information. I have in mind that quite a number of weekly papers are printed on Wednesday.

Mr. REID: Mr. President, I would say that probably the papers which are printed on Wednesday would not receive the information in time, and there is no practical way to include them. You can't expect the clerks of these committees to have that information on Tuesdays. They have to have until Wednesday and so the only weekly papers who benefit would be those that go to press on Thursday. This will provide a limited service to the weeklies at no cost to the state.

Mr. HASKELL of Penobscot: Mr. President and members of the Senate, I speak only for the purposes of the record. I shall vote for the motion but I would like to state my

understanding of the reasons I am voting for the passage of the order. The reasons are that a duly accredited representative of the weekly newspapers has presented to the Senate a plan designed by the weekly newspapers that the weekly newspapers are willing to undertake at their own expense. And in voting for the order we are attempting to meet their specifications, reserving to ourselves our own judgment as to whether or not it is entirely practical to give to any newspaper a partial list of hearings, recognizing the responsibility of the weekly newspapers for printing partial lists and recognizing that an inference that may be drawn from that list that such a list is a complete listing of all legislative hearings is entirely that of the weekly papers, that the plan is not conceived by the Senate nor that the plan as given to the weekly papers is all-inclusive and that will give to their readers a complete list of all the hearings.

I hope the weekly newspapers will make that clear to their readers so that none of them, having scanned such incomplete lists and not looking up the listings in the daily papers, will believe they have full listings of all hearings.

Mr. REID of Kennebec: Mr. President, I would like to say to the members of the Senate that the order was introduced by me endorsing the reservation of the Senator from Penobscot (Senator Haskell) and I would like to further state if this is not satisfactory to the weekly newspapers we can do no more and if they don't like it the way it is we cannot even do that.

The PRESIDENT: The question before the Senate is on the passage of the order, out of order and under suspension of the rules. Is it the pleasure of the Senate that, out of order and under suspension of the rules, the order receive passage?

The order received passage.

The PRESIDENT: The Senate is proceeding under Orders of the Day.

Mr. HASKELL of Penobscot: Mr. President, I ask unanmious consent to address the Senate. The subject will be a very brief summary of the position of the various committees with reference to the public hear-

ings. I assure the Senate it will not take more than two or three minutes.

Unanimous consent to address the Senate was granted.

HASKELL: Mr. President and members of the Senate, the order that we passed yesterday provided that the committee clerks would turn in to Waldo Clark a summary of their standings to date. Please believe me that I do not read this with even the remotest thought of criticism but only in order that each one of us in the Senate may have a general idea of the situation and I am not sure that it wouldn't be a good idea to have in the record each week some similar listing so that as the weeks go on we may have an idea of where we stand. This listing is subject to obvious errors that may have crept in and I do not vouch for its accuracy.

The Committee on Appropriations, for instance, has advertised all but 17 out of 47 bills; the Committee on Agriculture has advertised all their bills; the Committee on Business Legislation hasn't had but a few bills and neither has the Committee on Correctional Institutions; the Committee on Claims has advertised all but 9 out of 24 bills; the Committee on Education I don't think has as yet advertised any of the bills they have received; the Committee on Judiciary has unadvertised 39 out of 85 bills; the Committee on Fish and Game has 35 out of 58 bills not advertised; the Committee on Highways is yet to have advertised a public hearing, I think; the Legal Affairs Commit-

tee has advertised all but 5 out of 35 bills; the Committee on Labor has 5 remaining to be advertised out of 11; the Committee on Liquor Control has advertised just half of their bills, and the Committee on Natural Resources, a third of their bills; the Committee on Public Health I do not think has as yet had a public hearing; the Committee on Sea and Shore Fisheries have advertised all 12 of the bills they have had; the Committee on Taxation have 18 out of their 26 bills still unadvertised; Town and Counties, 16 out of their 26 bills unadvertised; and the Committee on Welfare have had 125 bills and have unadvertised 67.

I would hesitate to do this if we had a long calendar but that is where we all stand at present and I am sure that some comparison with prior years would indicate that we are going about our business in advertising hearings and holding executive sessions all to the end that we may have an orderly but not too long session.

The PRESIDENT: The Senate is proceeding under Orders of the Day.

Mr. HASKELL: Mr. President, I move that when the Senate adjourns, we adjourn until two o'clock tomorrow afternoon.

The motion prevailed, and on motion by Mr. Parker of Piscataquis,

Adjourned until tomorrow at two o'clock in the afternoon.
