Pursuant to the Senate Order requesting that this Commissioner report on three (3) phases of the work of this Department, I present to the Senate the attached records:

On Page 1, we show the projected new construction which is badly needed, almost to a point of emergency, together with additional operating costs caused thereby, and including the proposed salary increases which are presently being considered by the Legislature.

It shows the amount needed to balance the projected budget, and the sources from which these funds may be obtained, through an increase in license fees.

Page 2 shows the income from hunting and fishing licenses for ten (10) years together with all other income for the same period, and with the estimated income for 1952-1953, 1953-1954, and 1954-1955.

On page 3, we show the transactions of the Department over the past ten (10) years, and budget estimates for the years 1952 through 1955.

Amend said Bill by striking out the 28th, 29th, 30th and 31st lines thereof and inserting in place thereof the following underlined words and punctuation:

'the provisions of this subsection shall file with the tax assessors upon their request a report for its preceding fiscal year in such detail as the tax assessors may reasonably require. Any'

Which amendment was adopted and the bill as so amended was tomorrow assigned for second reading.

Mr. Carter from the same Committee on bill, An Act Relating to Certain Tax Exemptions for Amputee Veterans, (S. P. 55) (L. D. 83) reported that the same ought to pass as amended by Committee Amendment A.

Which report was read and accepted and the bill read once. The Secretary read Committee Amendment A:

COMMITTEE AMENDMENT "A" to S. P. 55, L. D. 83, Bill "An Act Relating to Certain Tax Exemptions for Amputee Veterans."

Amend said Bill by striking out the 3rd and 2nd lines from the end of section 1 and inserting in place thereof the following:

'designed motor vehicle, and who is otherwise qualified to operate a motor vehicle in this state, shall be required to pay the annual excise tax or'

Further amend said Bill by striking out the 4th and 3rd lines from the end of section 2 and inserting in place thereof the following: 'shall have a specially designed motor vehicle, and who is otherwise qualified to operate a motor vehicle in this state, such veteran shall be en-'

Further amend said Bill by striking out the 4th and 3rd lines from the end of section 3 and inserting in place thereof the following: 'ted disability who shall have a specially designed motor vehicle, and who is otherwise qualified to operate a motor vehicle in this state, such veteran'

Mr. CARTER: Mr. President I would like to present Senate Amendment A to this bill and will say that it is just to clarify a section to make the rules conform between the State Tax Assessor and the Secretary of State's office.

The Secretary read Senate Amendment A:

Senate Amendment A to S. P. 55, L. D. 83, bill "An Act Relating to Certain Tax Exemptions for Amputee Veterans."

Amend said bill by inserting therein a new section, to be numbered 3-A, to read as follows: "Sec. 3-A. R. S., c. 14-A, § 10, sub-§ XIV. Section 10 of chapter 14A of the revised statutes, as enacted by section 1 of chapter 250 of the public laws of 1951, is hereby amended by adding thereto a new subsection to be numbered XIV, to read as follows: 'XIV. Automobiles to amputee veterans. Sales of automobiles to veterans who are granted free registration of such vehicles by the secretary of State under the pro-

visions of section 13 of chapter 19. Certificates of exemption or refunds of tax paid shall be granted under such rules or regulations as the assessor may prescribe."

Thereupon, Committee Amendment A and Senate Amendment A were adopted and the bill as so amended was tomorrow assigned for second reading.

Orders of the Day

On motion by Mr. Dunham of Hancock the Senate voted to reconsider its former action taken earlier in today's session whereby bill, An Act in Favor of the Town of Gouldsboro (S. P. 287) was referred to the Committee on Appropriations and Financial Affairs; and on further motion by the same Senator the bill was laid upon the table pending reference to a committee.

On motion by Mr. Dennett of York the Senate voted to take from the table, House Report "Ought Not to Pass" from the Committee on Inland Fisheries and Game on bill, An Act Relating to Hunting Licenses for Minors (H. P. 12) (L. D. 6), tabled by that Senator on February 12th pending acceptance of the report, and that Senator yielded to the Senator from Penobscot, Senator Wight.

Mr. WIGHT of Penobscot: Mr. President, the Committee on Inland Fisheries and Game is considering two other measures relating to this

subject and so we think it might be advisable to consider them all together. We therefore ask that this bill be recommitted to the Committee on Inland Fisheries and Game.

The motion to recommit prevailed.
