Thursday, February 19, 1953.

Mr. CHAPMAN of Cumberland: Mr. President, in the interests of the early disposition of our accumulative matters it is my desire to schedule for consideration the first tabled and unassigned matter, House Paper 479, Legislative Document Number 450. On that premise I move that the matter be taken from the table and further move that it be retabled and assigned for consideration on Wednesday, February 25th.

The Senate thereupon voted to take from the table "Resolve Appropriating Money for the Continued Study of the Maine State Liquor Monopoly Operations" (H. P. 479) (L. The motion to refer prevailed. Sent down for concurrence.

On motion by Mr. Broggi of York the Senate voted to take from the table bill, An Act Providing for the Method of Payment of Wages by Check or Draft (H. P. 660) (L. D. 703), tabled by that Senator on February 18th pending reference to a committee in concurrence.

Mr. BROGGI: Mr. President, to borrow a quote from a fine friend and a fine colleague, I move that this bill be assigned to the proper committee.

Thereupon the bill was referred to the Committee on Labor in concurrence.

On motion by Mr. Littlefield of York the Senate voted to take from the table House Report "Ought to Pass" from the Committee on Sea and Shore Fisheries on bill, An Act Relating to the Biennial Revision of Sea and Shore Fisheries Law (H. P. 151) (L. D. 148), tabled by that Senator on February 12th pending acceptance of the report in concurrence, and on further motion by the same Senator the report was accepted in concurrence and the bill read once.

The same Senator then presented Senate Amendment A:

"Amend Section 113 of said bill by inserting after Paragraph 4 of said section the following: 'Provided further that anyone engaged in the smoking of alewives or herring as smoked herring or bloaters shall be exempt from the licensing provisions of said section.'"

Senate Amendment A was adopted and the bill as amended was tomorrow assigned for second reading.

On motion by Mr. Dunham of Hancock, the Senate voted to take from the table Resolve in Favor of the Town of Gouldsboro (S. P. 287) tabled by that Senator on February 18 pending reference to a committee.

Mr. DUNHAM: Mr. President, having the greatest trust and confidence in the Committee on Appropriations and Financial Affairs, I now move that this bill be referreed to that committee.

The motion to refer prevailed. Sent down for concurrence.

Mr. Chase of Washington was granted unanimous consent to address the Senate.

Mr. CHASE: Mr. President, Legislative Document 428 contains within the Statement of Facts, an error, a line having been admitted which completely reverses the purpose and intent of the bill. So if any Senators read it over the weekend, they will understand that. A new copy is being prepared and will be distributed.

On motion by Mr. Haskell of Penobscot, the Senate voted to take from the table House Report from the Committee on Transportation on bill, An Act Relating to Carrying Motor Vehicle License by Operator (H. P. 293) (L. D. 278) tabled by that Senator earlier in today's session pending consideration.

Mr. HASKELL: Mr. President, if we were at the stage of our proceedings where we had a calendar that required a lot of time under Orders of the Day, I would not attempt to make the motion that I will make.

This bill was heard by the Committee on Transportation. It looked to be an innocent enough bill in that it provided that the operator's license should be carried on the person of the operator. There may be some compelling reason why the law should require us to carry our registration certificate but not require us to carry an operator's license.

The bill came into the other Branch with an "Ought to pass" report. A motion to indefinitely postpone was made and I am told no debate ensued either by the maker of the motion or anyone who might have been interested in having the position of the committee prevail. There may well be arguments against it but by supporting a motion to accept the ought to pass report of the committee in non-

concurrence, it goes back to the other Branch in non-concurrence and there, I would hope that the opponents of the bill would stand up and say what is wrong with it. So, Mr. President, I move the acceptance of the "Ought to Pass" report of the committee.

Thereupon, the Ought to Pass report of the committee was accepted in non-concurrence, the bill was given its first reading and tomorrow assigned for second reading.

Mr. Haskell of Penobscot was granted unanimous consent to address the Senate.

Mr. HASKELL: Mr. President, I rise only to state that so far as the Reference of Bills Committee is concerned we are planning on another week, just as we have had this week, still hopeful that the committee chairmen will have advertised as they did this week, a full and busy

Thursday morning of committee hearings.

The PRESIDENT: Before the Secretary reads the notices, Chair would like to remind the Senate that our capable Director of Legislative Research has advised the Chair that there are a number of bills that have been proposed to be introduced by members of the Senate, which are available for introduction as soon as they are signed. Therefore to facilitate the work of the session, it would be appreciated if any of the individual Senators, knowing of pending legislation which they propose to sponsor, would check with the Revisor of Statutes.

The Senate is proceeding under Orders of the Day.
