SENATE

Thursday, March 5, 1953.

The Senate was called to order by the President.

Prayer by the Rev. David Flowers of Augusta.

Journal of yesterday read and approved.

Orders

Mr. Haskell of Penobscot presented the following Order, out of order and under suspension of the rules, and moved its passage:

ORDERED, the Senate to acknowledge the excellent behavior of Senator Jamieson's young grandson by naming H. Richard Crandall of Presque Isle as honorary page of the Senate for this legislative day.

Thereupon, the Order received a passage and the Senator from Aroostook, Senator Jamieson, escorted his grandson, H. Richard Crandall to a seat with the Senate Pages.

Since the Senate would be reluctant to miss such a spectacle I have agreed to move that this matter be retabled and especially assigned for next Wednesday. Mr. Boucher of Androscoggin was granted unanimous consent to address the Senate.

Mr. BOUCHER: Mr. President and members of the Senate, after the tongue lashing which my good friend, Senator Chase of Cumberland, has just given me I assure him I will do my best to beat him next Wednesday. I hope the mem-

bers of the Senate will not take this as a partisan matter because we have had partisan matters before. This bill affects Democrats and Republicans alike. I shall be glad to debate this matter next Wednesday. I wish I had not had this terrible head cold for I would have been glad to have debated it today and get it over with. I will get some fire-water from the Indians up in Old Town tomorrow, and I want Senator Chase to be prepared.

On motion by Mr. Haskell of Penobscot, the Senate voted to take from the table, Bill, An Act Relating to Lights on Boats (S. P. 376) (L. D. 1039) tabled by that Senator earlier in today's session pending reference.

Mr. HASKELL: Mr. President. this matter is now in non-concurrence. The Senate has previously honored the Committee on Natural Resources. The other body gave nod to the Committee on Transportation. The chairmen of those two committees have discussed the matter, I think both fair and honorable men, but I regret to report we were unable to agree on the disagreeing action, but we did explore another area and I am pleased to report we are unanimous in suggesting you support the motion to indefinitely postpone, which I now make.

The motion to indefinitely post-pone prevailed.
