## SENATE

### Tuesday, March 10, 1953

The Senate was called to order by the President.

Prayer by the Rev. Douglas H. Robbins of Augusta.

Journal of Thursday, March 5, 1953, read and approved.

#### Order

On motion by Mr. Haskell of Penobscot, out of order and under suspension of the rules, it was

ORDERED, that a message be sent to the House of Representatives proposing a solemn Joint Convention to be held in the hall of the House forthwith, for the purpose of considering such resolutions as may seem fitting in relation to the untimely death of the Chief Justice of the Supreme Judicial Court of Maine, Justice Harold Hall Murchie.

Thereupon, the Secretary of the Senate, Chester T. Winslow, delivered the message.

Subsequently a message was received from the House of Representatives by its Clerk, Harvey R. Pease, that the House concurred in the proposal for a Joint Convention.

The Senate retired to the Hall of the House where a Joint Convention was formed.

#### In the Senate

The Senate was called to order by the President.

On motion by Mr. Haskell of Penobscot, out of order and under suspension of the rules, it was

ORDERED, the House concurring, that a Joint Select Committee consisting of the President and three members of the Senate, and the Speaker and five members of the House of Representatives, be charged with the solemn duty of representing the 96th Legislature at the funeral services of the late Chief Justice Harold H. Murchie. (S. P. 477)

The President appointed as members of such committee, on the part of the Senate, Senators Haskell of Penobscot, Reid of Kennebec and Boucher of Androscoggin.

The Order was sent to the House forthwith for concurrence.

Mr. CHAPMAN of Cumberland: Mr. President and members of the Senate, as has been rather vividly pointed out, this hardly seems to be the day for a rough and tumble debate on the matter under consideration, consequently I will make a suggestion which I think will avoid it for today, at least. However, it was my original intention to move acceptance of the Minority Report for one purpose and one purpose only, and that was to keep the bill alive long enough to have opportunity to offer an amendment. I would like to do that today because I think it is the kind of proposition that is sanctioned under our senatorial courtesy. I might say that I have discussed it with the Chairman of the Committee on Judiciary. He is not now here but he has told me that this procedure would be agreeable. It was my intention, after offering this amendment for adoption to suggest tabling that it may have full consideration Thursday next, and I think there would be opportunity to grind into this bill, those who desire to do so. With that preliminary argument I move the acceptance of the Minority Report, for the purpose as stated.

Thereupon the Minority Report "Ought to Pass" was accepted, and the bill was given its first reading.

Mr. Chapman offered Senate Amendment "A" and moved its adoption:

"Senate Amendment 'A' to S. P. 81, L. D. 188, Resolve, Proposing an Amendment to the Constitution to Reduce the Voting Age to Eighteen Amend said Resolve by Years. striking out the word 'Eighteen' in the 2nd line of the Title thereof, and inserting in place thereof, the word 'twenty'. Further amend said Resolve by striking out the under-lined word 'eighteen' in the 7th line thereof, and inserting in place thereof the underlined word 'twenty'. Further amend said Re-solve by striking out the word 'eighteen' in the last line of the 3rd paragraph from the end thereof, and inserting in place thereof the word 'twenty'

Thereupon, Senate Amendment "A" was adopted, and on motion by Mr. Chapman of Cumberland the bill and accompanying papers were laid upon the table pending assignment for second reading, and especially assigned for Thursday, March 12th.

Mr. WIGHT of Penobscot: Mr. President, I would inquire as to whether H. P. 267, L. D. 304, Resolve, Regulating Ice Fishing in Coffee Pond, Cumberland County, is in the possession of the Senate?

The PRESIDENT pro tem: The Chair will inform the Senator the Resolve is in the possession of the Senate.

Thereupon, on motion by Mr. Wight of Penobscot the resolve was recommitted to the Committee on Inland Fisheries and Game in nonconcurrence.

Sent down for concurrence.

Mr. WIGHT of Penobscot: Mr. President, I would inquire if H. P. 90, L. D. 94, Resolve, Authorizing the Commissioner of Inland Fisheries and Game to Pay Certain Claims, is in the possession of the Senate?

The PRESIDENT pro tem: The Chair will inform the Senator that

the resolve is in the possession of the Senate.

Thereupon, on motion by Mr. Wight of Penobscot, the Senate voted to reconsider its action whereby the resolve was indefinitely postponed in non-concurrence; and on further motion by the same Senator, the resolve was laid upon the table pending consideration.

On motion by Mr. Silsby of Hancock, the Senate voted to take from the table, "Ought to Pass" report from the Committee on Claims on Resolve, in Favor of Freelow Crummit of Whitefield, (H. P. 404) (L. D. 1159) tabled by that Senator earlier in today's session pending consideration. Mr. SILSBY of Hancock: Mr. President, I was a bit uncertain as to what this resolve was all about but I find after examining the resolve that it is one of these socalled "deer claims", and I think the Senate has expressed very emphatically that they are not in favor of paying such claims, and I move we concur with the House in indefinitely postponing this resolve.

The motion prevailed and the resolve was indefinitely postponed, in concurrence.
