SENATE

Thursday, March 12, 1953.

The Senate was called to order by the President.

Prayer by the Rev. Marvin Palmerlee of Augusta.

Journal of yesterday read and approved.

On motion by Mr. Haskell of Penobscot, out of order and under suspension of the rules:

ORDERED, the House concurring, that when the Senate and House adjourn, they adjourn to meet on Tuesday, March 17, 1953, at ten o'clock in the forenoon. (S. P. 489)

The President laid before the Senate, Resolve Proposing an Amendment to the Constitution to Reduce the Voting Age to Eighteen Years (S. P. 81) (L. D. 188) tabled on March 10th by the Senator from Cumberland, Senator Chapman, pending assignment for second reading.

Mr. CHAPMAN: Mr. President and fellow members of the Senate you will recall that a few days ago when we by courtesy accepted the minority report of the committee for the purpose of presenting an amendment, which was adopted, the matter was reassigned for full consideration for today. It was my thought at the time the amendment was adopted that it might change the sense of the bill at least sufficiently to make it acceptable to the greater number of the members of this Body and to the committee. As a matter of fact, the reason the amendment was proposed was because at the time the bill was in committee and for some time thereafter there was some thought that it might be amended to apply somewhere between the ages of eighteen and twenty-one, which might be acceptable. I find upon inquiry that there is no such sentiment, as far as I can find. You will recall that the committee was nine-teen to one "Ought Not to Pass." I have a great deal of respect for the judgment of the committee and I think the remarks I made previously on another bill about two weeks ago relating to the four year term for governor also apply to this proposal. I think the proposal is a good one. I think it

is a sound proposal but I am nevertheless going to move the indefinite postponement of this resolve and there are a couple of reasons for my doing so. I have previously explained my reason for doing it but I would like to add that when I tabled this bill a few days ago I assured the members of this Body that there would be full opportunity to dispose of it if they so wished and I wish to live up to that assurance. Secondly, if the bill is going to be buried, as it is, I, frankly, as the sponsor of it would like to be the chief officiator at the interment.

I therefore now move that this resolve, Legislative Document 188, be indefinitely postponed. I make that motion reluctantly but I do make it.

Thereupon the resolve was indefinitely postponed.

Sent down for concurrence.

On motion by Mr. Weeks of Cumberland the Senate voted to take from the table bill, An Act Relating to the Salary of the Judges of the Winthrop Municipal Court (H. P. 285) (L. D. 270), tabled by that Senator on March 10th pending passage to be engrossed; and on further motion by the same Senator the bill was passed to be engrossed in concurrence.

On motion by Mr. Chase of Cumberland the Senate voted to take from the table, Resolve Proposing an Amendment to the Constitution Providing for One Hundred and Fifty-six State Representatives (S. P. 483) tabled by that Senator earlier in today's session pending reference.

Mr. CHASE: Mr. President, it would not be appropriate for me to speak in opposition to a resolve which I have today seen for the first time and which has not yet been referred to a committee but in view of the existing situation I do want to be the first to call the attention of this legislature to the fact that if the Constitution should be amended as is here proposed Cumberland County would be entitled to 28 representatives instead of 27 as contained in the bill presented to the Senate today by the Committee on Reapportionment. I also wish to point out that any

amendment to the Constitution which would enlarge the House, if the other provisions in the Constitution were not changed at the same time, would inevitably tend to greatly increase the representation of the larger cities and towns.

Mr. President, I move that the resolve be referred to the Commit-

tee on Judiciary.

Mr. BUTLER of Franklin: Mr. President and members of the Senate, in addition, not only would Cumberland County gain but also the County of Penobscot and without doubt the County of Aroostook. There is so much uncertainty as to what would be the result even though it is perhaps referred to the Committee on Judiciary that I am going to move reconsideration of the motion to refer, or, in other words, I am opposing this motion to refer to the Committee on Judiciary, at the present time, and if that motion is unfavorably acted upon I then will present a motion for indefinite postponement.

Mr. CHAPMAN of Cumberland: Mr. President and fellow members of the Senate, I do not like to rise in opposition to the motion, or what might be a motion, by the Senator from Franklin, but I think there is only one proper thing we can do and that is to refer the resolve to a committee and then the matter may be debated on its merits. I therefore strongly urge that the motion to refer be carried. Whatever happens after that will be another matter and we can consider it at another time.

The PRESIDENT: The question before the Senate is on the motion of the Senator from Cumberland, Senator Chase, that the resolve be referred to the Committee on Judiciary.

A viva voce vote being had The resolve was referred to the Committee on Judiciary.

Ordered printed.

Sent down for concurrence.

On motion by Mr. Hanson of Washington the Senate voted to take from the table, bill An Act to Amend the Exemption in the Sales and Use Tax Law Respecting Hospitals (S. P. 72) (L. D. 156), tabled by that Senator on March 4th pending passage to be engrossed, and that Senator yielded to the

By 'hospital supplies and equipment' is intended all tangible personal property bought for the care, treatment and housing of patients of the hospital or any other purpose necessarily incident to the operation of the hospital."

Senate Amendment A was thereupon adopted and the bill as so amended was passed to be en-

grossed.

On motion by Mr. Ward of Penobscot the Senate voted to take from the table, bill, An Act to Clarify the Sales and Use Tax Law (S. P. 141) (L. D. 341) tabled by that Senator on March 4th pending passage to be engrossed; and that Senator presented Senate Amendment A and moved its adoption.

Mr. COLLINS: Mr. President, it is not my intention to present any discussion on this appropriation bill at this late hour of Thursday afternoon. However, I do feel that it would be in order if the report of the committee could be accepted and the bill given its first reading and under suspension of the rules be given its second reading. in no way would eliminate debate nor would it in any way eliminate opportunities for amendments to the bill when it comes up for consideration. If granted that privilege I would then ask that the bill be tabled again and especially reassigned for next Tuesday, at which time I would like to give an anlysis of the bill as members of the Appropriations Committee understood it. With that in mind I move Mr. President, that the "Ought to Pass" report of the committee be cepted.

The report of the committee was accepted and the bill was given its first reading, and under suspension of the rules was given its second reading.

On motion by Mr. Collins of Aroostook, the bill was laid upon the table pending passage to be engrossed, and especially assigned for Tuesday next.

On motion by Mr. Haskell of Penobscot, the Senate voted to take from the table, Resolve Regulating Fishing in East Branch Tributaries of the Penobscot River (H. P. 101) (L. D. 102) tabled by that Senator earlier in today's session pending consideration.

Mr. HASKELL of Penobscot: Mr. President and members of the Senate, this resolve comes over here in non-concurrence, we having passed it to be engrossed, and the House having amended it. If ever

I became completely inconsistent in talking about this bill I am inconsistent now because I have stood here and supported committee reports and am going to do the same thing next week and the following weeks, but this one I find very difficult to buy. I would not for a moment think of opposing a unanimous committee report unless I thought I had some information that was not available to the committee. Now, it happens this was a bill that came to the committee, I am told, with department sponsor-ship and seems to do something to the fishing procedures on the East Branch of the Penobscot River.

Now, so far as the East Branch of the Penobscot River is concerned. I happen to know all of the honest fishermen and most of the honest visitors and all of the poachers, and I am reasonably well acquainted with most of the adult fish in that country, and I don't see any evidence that the poachers, the natives, or the fish want the rules, whatever they are, puttered with up in the East Branch. We have got along up there pretty well for a long, long time. The only difficulty we have is on the rare occasions when he have a warden come into the country, but not very often. It seems to me unless there are some compelling reasons to be presented by this good committee, following their report—and I will normally stand by this report—it seems to me you ought to leave us alone up there and not force on us a bill we natives don't know anything about. I made a special trip up there last week-end to talk with the natives and the poachers, and no one knew anything about it. It looks to me like this is a city bill. All I ask is that you just leave us alone. To me there is a principle. I cite that principle to the Senator from Androscoggin, Senator Boucher. It is home rule. It is all I ask, to be left alone. When the department comes up or sends wardens and catches us and finds us in non-concurrence with their thoughts, I might buy the deal. It looks to me like an attempt to take home rule away from us in the East Branch of the Penobscot River, and I don't like it.

I move, Mr. President, that this bill be indefinitely postponed.

Mr. DUNHAM of Hancock: Mr. President, I take no exception to the argument of the good senator from Penobscot, Senator Haskell, but when he says he knows all the honest fishermen I say he is taking a lot of liberty with the English language, because who ever met an honest fisherman?

Mr. BOUCHER of Androscoggin: Mr. President, I would like to ask, through the Chair, a question of the Senator from Penobscot, Senator Haskell.

The PRESIDENT: The Senator from Androscoggin may ask a question through the Chair of the Senator from Penobscot, and that Senator may answer if he cares to.

Mr. BOUCHER: I would like to know if Indian Island is on the East Branch of the Penobscot River?

Mr. HASKELL: I am glad to answer that and am glad the question was raised. I didn't give you all the facts on this thing. I fussed a little bit to the sponsor of this bill and asked him just what he was doing in the upper regions of the East Branch. That is what he has done, he has pulled himself down toward Indian Island but still not as far down as I would like to see him. It is a big country up there, 643 1-2 square miles of drainage area. He allowed he had never been up there. It would be perfectly all right with me if he would leave us alone. Then he picked up the Sebasticook and Sebois area. He said, "Do you ever fish up there?" I said, "Yes." He said, "You would not feel as bad about that as up in your country?" I said, "Not quite." That is what this amendment is. But there is still the question of home rule. We will suffer your wardens when you have to send them up there, but I don't subscribe to the theory of some legislator coming up there and stirring up that with which we have got along with some time. It is not right.

Mr. BOUCHER: Mr. President, I want to thank the Big Chief of Penobscot for the answer he has furnished me.

Mr. WEEKS of Cumberland: Mr. President and members of the Senate, I am one of that unholy ten who sat on the Fish and Game Committee hearing and passed this

bill out unanimously, and possibly it is not admitting too much to admit I didn't know altogether too much about the area up there about which the Senator from Penobscot, Senator Haskell, is so worried. I heard words such as Matta Gamma Dam and a few other words. (Laughter) In the course of the discussion on the contrary to what the Senator from Penobscot. Senator Haskell. said. I did hear some very strong recommendations from members of the department. Their criticism of the present situation was not necessarily against fishermen as such in fishing, not against poachers, but it seems there are a lot of city fellows who come up there with their big flat feet and stir up the spawning beds at a very vital time. I don't know whether they were washing their feet or what they were doing but the serious thing was the stirring up of the spawning beds during the period. I confess that my knowledge of the picture up there is not very keen. It was a conservation measure, as we understood it, and I am willing to abide by the Governor's statement. If we are wrong in our information I am one of the first to recede and concur.

Mr. HASKELL: Mr. President. my apologies for rising a third time. I was rather inclined to buy that theory of the thing until the committee cuts the draining area right in two with all the spawning beds, and said "Up where the fish will spawn we will take out and leave the lower reaches of the stream in there." If the theory is sound let's talk about that, the original bill. and not talk about this amendment. As a matter of fact, Mr. President, we raise more fish from natural spawning in the East Branch than in any other part of the State of Maine. We are sportsmen up there of the type that know where the spawning grounds are and we never go near them during the spawning season.

In summary, we will take the wardens, but we don't like to compromise. If the theory of the committee is right, let's take the whole base and we will abide by it, but to come up there and say the lower reaches down nearer the city ought to be in one category and leave

the rest alone doesn't seem to me to be right. If you want to debate on the whole issue—the bill as originally put in is all right, but to come in with a compromise of the thing just to quiet the fish and natives and poachers doesn't seem to me to establish a good principle.

Mr. WEEKS of Cumberland: Mr. President, may I request the reading of House Amendment "A"?

The Secretary read House Amendment "A".

Mr. WIGHT of Penobscot: Mr. President, I suppose this debate would not be complete unless the Chairman of the Inland Fisheries and Game Committee had at least a few words to say. I think this is one for the book and we should give the cat a doughnut, because the Senator from Penobscot, I believe on every occasion, has supported the committee previously, and now takes this stand on this bill. We heard this bill and there were some in favor of the bill and none in opposition to the bill, whatsoever. That is my only criticism. I think it is of inconsequential importance, especially so since the amendment has been put on the bill.

The PRESIDENT: The Chair understands the motion before the Senate is that the bill be indefinitely postponed.

The motion prevailed, and the bill was indefinitely postponed in non-concurrence.

Sent down for concurrence.

On motion by Mr. Chapman of Cumberland, the Senate voted to take from the table, Bill, An Act Relating to Limitation of Slander and Libel Suits (S. P. 486) tabled by that Senator earlier in today's session pending reference.

Mr. CHAPMAN: Mr. President, I would like to take this opportunity to make a proper motion which I believe is to postpone consideration of this bill, reference or otherwise, until a date certain, to wit, next Tuesday, March 17th. The purpose of this is a detail in regard to reference has not been able to be worked out because the chairman of the committee is not present. I am aware of the fact that matters piling up on the table will slow us down but I believe with the time between now and Tuesday there will be no prejudicial delay.

Thereupon, the bill was laid upon the table pending reference, and especially assigned for Tuesday next.

On motion by Mr. Chapman of Cumberland, the Senate voted to take from the table, Bill, An Act Permitting the Separation of Cumberland Foreside from the Town of Cumberland (S. P. 438) tabled by that Senator earlier in today's session pending reference; and on further motion by the same Senator, the bill was laid upon the table pending reference, and especially assigned for Tuesday next.

On motion by Mr. Haskell of Penobscot,

Adjourned until Tuesday, March 17th, at ten o'clock in the forenoon.
