#### SENATE

Tuesday, September 21, 1954

In compliance with a Proclamation of His Excellency, the Governor Burton M. Cross, the Senators convened in the Senate Chamber at four o'clock in the afternoon, Eastern Standard Time.

The Senate was called to order by the Assistant Secretary.

Prayer by the Rev. Douglas H. Robbins.

The Assistant Secretary read the Proclamation:

STATE OF MAINE PROCLAMATION BY THE GOVERNOR

WHEREAS, it appears advisable that the Legislature of this State should meet in special session for the following purposes:

To consider legislation relative to the 1954 revision of the statutes.

To consider temporary emergency legislation to bring Maine in conformity with the other New England States on Daylight Saving Time.

To consider clarification of the joint legislative order passed in 1953 in relation to employees' salaries.

To consider any other legislation to promote the general welfare of the State.

NOW, THEREFORE, I, BUR-TON M. CROSS, Governor of the State of Maine, by virtue of the power vested in me as Governor, convene the Legislature of this State, hereby requiring the Senators and Representatives to assemble in their respective chambers at the Capitol at Augusta on Tuesday, the twenty-first day of September, 1954, at four o'clock in the afternoon in order to receive such communication as may then be made to them and to consider and determine on such measures as in their judgment will best promote the welfare of the State.

Given at the office of the Governor at Augusta and sealed with the Great Seal of the State of Maine, this twenty-fourth day of August in the year of our Lord One Thousand Nine Hundred and Fifty-four, and of the Independence of the United States of America, the One Hundred and Seventy-ninth.

The roll being called, the following Senators responded to their names:

Thirty Senators having answered to the roll call, the Secretary declared that a quorum was present.

On motion by Mr. Haskell of Penobscot, Mr. Parker of Piscataquis was appointed a committee of one to cast one ballot on the part of the Senate in favor of the Honorable John F. Ward of Penobscot for President of the Senate; and that Senator having performed the duty assigned him, the Secretary declared the Honorable John F. Ward duly elected President of the Senate for the remainder of the political year 1954.

Mr. Ward was escorted to the Chair by Mr. Boucher of Androscoggin, and thereupon addressed the Senate as follows:

Mr. WARD of Penobscot: Members of the Senate, I thank you very sincerely for the honor that you have just conferred upon me. I am aware of the responsibilities of the office, and I shall endeavor to the best of my ability to carry them out and to preside over your meetings in a fair and impartial manner.

The Chair now awaits the pleasure of the Senate.

On motion by Mr. Chapman of Cumberland, Mr. Fuller of Ox-

ford was appointed a committee of one to cast one ballot on the part of the Senate in favor of the Honorable Chester T. Winslow of Raymond for Secretary of the Senate; and that Senator having performed the duty assigned him, Chester T. Winslow of Raymond was declared duly elected Secretary of the Senate for the remainder of the political year 1954.

At the request of the President, Mr. Chapman of Cumberland escorted the Secretary-elect to the Council Chamber for the purpose of taking and subscribing to the necessary oaths of office to qualify him to enter upon the discharge of the duties of the Secretary of the Senate.

Subsequently, Mr. Chapman reported to the Senate that he had attended to the duty assigned to him, and that Chester T. Winslow had, before the Governor and Council, taken and subscribed the oaths of office required to qualify him for the discharge of the duties of the Secretary of the Senate.

ORDERED, that the Secretary of the Senate be authorized to procure the services of three stenographers for this special session:

one for the office of the President and two for the office of the Secretary.

On motion by Mr. Squire of Kennebec, it was

ORDERED, the House concurring, that three hundred and fifty copies of the Legislative Record for this Special Session of 1954, convened on September 21, be printed and bound, one copy each for the members and officers of the Senate and House of Representatives, and the remainder to be deposited in the State Library for exchange and library purposes; and it was further

ORDERED, that three hundred and fifty copies of the Legislative Record be printed in pamphlet form for distribution from day to day to members of the Legislature and the departments, under the direction of the Document Clerk. (SP 620)

ORDERED, that the Senate Reporter be authorized to employ an assistant reporter during this Special Session.

ORDERED, the House concurring, that the Secretary of the Senate and the Clerk of the House be directed to furnish to each member and officer of the Senate and House a copy of the State newspaper each morning during the present special session of the Legislature. (SP 621)

Sent down for concurrence.

Subsequently the foregoing order was returned from the House having been read and passed in concurrence.

On motion by Mr. Haskell of Penobscot, it was

ORDERED, the House concurring, notwithstanding any previous cloture orders passed by the Ninety-sixth Legislature, that no bill or resolve be received at this Special Session of the Legislature unless deposited with the Secretary of the Senate or the Clerk of the House before fivethirty p.m.. Eastern Standard Time (six-thirty, Daylight Saving Time) Tuesday, September 21, 1954, except by unanimous consent in the body in which it is introduced, and it was further

ORDERED, that any bill or resolve which shall be received in either body of this Legislature by unanimous consent after five thirty p.m., Eastern Standard Time (six-thirty p.m. Daylight Saving Time) Tuesday, September 21, 1954, shall be referred to the Ninety-seventh Legislature if unanimous consent for its reception is not given in the other body in concurrence.

On motion by Mr. Haskell of Penobscot, sent forthwith to the House for concurrence.

On motion by Mr. Harding of Knox, it was

ORDERED, that a message be sent to the House of Representatives proposing a Joint Convention to be held forthwith in the Hall of the House for the purpose of extending an invitation to the Governor to attend the Convention and present such communication as he may be pleased to make.

The Secretary conveyed the message.

Subsequently a message was received from the House by Mr. Pease, its Clerk, concurring in the foregoing proposition for a Joint Convention.

The Senate then proceeded to the House of Representatives where a Convention was formed.

In accordance with the provisions of Section 6, Article X of the constitution of the State of Maine, I herewith submit to the legislature for approval my arrangement of the constitution, as amended, under appropriate titles and in proper articles, parts and sections, in which I have omitted all sections, clauses and words not in force, and making no other changes in the provisions or language thereof.

I have adopted, as far as possible, the arrangement made by Chief Justice Murchie in 1951, which was approved by the legislature, and published under the direction of the Secretary of State as authorized by Chapter 5 of the Resolves of 1951. I have also continued the previous system of identification of each amendment, by adding the date of the legislative resolve proposing its submission for adoption, and by the chapter number of such resolve.
