Tuesday, January 11, 1955

The House met according to adjournment and was called to order by the Speaker.

Prayer by the Rev. Mr. Christo-

pher of Augusta.

The members stood at attention during the playing of the National Anthem.

The journal of the previous session was read and approved.

Paper from the Senate

From the Senate: The following

ORDERED, the House concurring, that the Secretary of the Senate and the Clerk of the House jointly prepare the Senate and House Register, and that 5,000 copies be printed for the use of the Legislature (S. P.

Came from the Senate read and passed.

In the House, the Order was read. Mr. Childs presented House Amendment "A" and moved its adoption.

House Amendment "A" was read by the Clerk as follows:

AMENDMENT "A" HOUSE to Joint Order, S. P. 17, relative to Senate and House Register.

Amend said Order by striking out the figure "5000" in the fourth line thereof, and inserting in place thereof the figure '6000.'

The Committee on Rules and Business of the House recommended the consideration of this Order without reproduction or printing.

Amendment House was adopted and the Joint Order as amended by House Amendment "A" was passed in non-concurrence and sent up for concurrence.

The SPEAKER: The Chair is informed that on the House Advance Journal is a communication from the State of Maine, Department of Labor and Industry. This is a duplicate of a similar communication going to the Senate this morning and for that reason will not be taken up at this time.
