Orders

On motion of Mr. Call of Cumberland, it was

ORDERED, that Rev. Valton V. Morse of Congregational Parish, Cumberland Center, be invited to officiate as Chaplain of the House on Tuesday, February 15, 1955.

The SPEAKER: The Chair recognizes the gentleman from Bucksport, Mr. Pierce.

Mr. PIERCE: Mr. Speaker, I present an order and move its passage. I request the privilege of speaking briefly on the matter.

The SPEAKER: The gentleman from Bucksport, Mr. Pierce, presents an order and moves its passage. The Clerk will read the order.

ORDERED, the Senate concurring, that the State Controller supply for use of the Legislature two hundred copies of a list of State Employees with their salaries as of December 31, 1954, and be it further

ORDERED, that said lists be distributed, one to each member of the Senate, House and Council; two to the Executive; one to the Secretary of the Senate; one to the Clerk of the House; and the balance to the State Librarian for exchange purposes.

The SPEAKER: The Chair recognizes the gentleman from Bucksport, Mr. Pierce.

Mr. PIERCE: Mr. Speaker and Ladies and Gentlemen: For many years this little book that I hold in my hand used to be called the "snoop book". It was done because before Personnel became operative it was the privilege of the heads of departments to establish the salaries of their subordinates, their clerks. Since Personnel, the amount that each employee receives is well publicized. Each person knows exactly how much his co-workers and the workers of the other departments are receiving. That list is available to anybody in the office of the Controller but I might add, ladies and gentlemen, that it is published on sheets very similar to this size. Any person can go and find out exactly how much the other fellow is getting. There is no further use of calling it a "snoop book" because of its wellpublicized method of handling at this moment. Everybody knows except us how much we are paying our employees of the State. I investigated through the Controller last week and find that our weekly payroll of employees is in excess of \$400,000. I ask you, ladies and gentlemen, how can we intelligently vote upon the many matters that will come before us unless we have these facts and figures readily available to us in this special form? You can see that this one was issued to me in 1951 and it is well used. In '53. for some reason, it was not published. The reason, I do not know. The cost of the printing has been brought to my attention. It is, for this particular book, I believe, \$460 and at this time we had 500 copies printed. My order calls for only 200. Inasmuch as it goes to competitive bidding, I can not give you a figure but I can reasonably assume it would be substantially under \$500 and having served here for a number of years, I assure you, ladies and gentlemen, that it is a valuable property to possess in our deliberations and I trust that my order has a passage. Thank you.

The SPEAKER: The Chair recognizes the gentleman from South Portland, Mr. Fuller.

Mr. FULLER: Mr. Speaker, I hate to disagree with my friend, the gentleman from Bucksport, Mr. Pierce. but I am sure that he will agree that that is my privilege. We may all obtain the salaries of all State employees in the Controller's office at any time. They are there for us to look at and I think it can serve no useful purpose to have them published. It can cause many hard feelings and any small courtesies that we can give to our State employees I think we should give and I think this is one time when we could extend to them a small courtesy which would be appreciated. I can see again no useful purpose for publishing this book and I move indefinite postponement of this order. Mr. Speaker, when the vote is taken I move that it be taken by division.

The SPEAKER: The gentleman from South Portland, Mr. Fuller, moves that the joint order be indefinitely postponed and the same gentleman requests a division.

The Chair recognizes the gentleman from Portland, Mr. McGlauflin.

Mr. McGLAUFLIN: Mr. Speaker. I had no thought of taking any part in the discussion of this measure but one of the Senators, who is opposed to this order, called my attention to the fact that such an order was coming in and he wanted me to oppose it. I said I would give it consideration. The first thing that I wanted to find out was whether, as I was told. the help of the State House were very much opposed to this matter. I interviewed, personally, six different parties in the State. Each one told me that he had no slightest objection to the publication and I was told that in some departments, like the Motor Vehicle Department, there was considerable curiosity as to what each one was paid. As to that part, I will state that these employees are paid on a schedule. Everybody knows that they start on a certain rate and after a certain time they are increased.

Now, I have used this book that has been published before and I always liked to have the book. I wouldn't want to have the book if it is going to cause a great deal of trouble among the employees but from my investigation I am convinced that that is not the case, so I am going to cast my vote against this motion for indefinite postponement and support the gentleman from Bucksport, Mr. Pierce, on his order.

The SPEAKER: The Chair recognizes the gentleman from Augusta, Mr. Albert.

Mr. ALBERT: Mr. Speaker and Members of the House: The gentleman from South Portland, Mr. Fuller, has pointed out to us that the information is readily available at the State Controller's office. I want to mention this because a lot of the Representatives here do not live in the City of Augusta or Hallowell where they are handy to the State Controller's office. Also that you are elected for a period of two years. Consequently after you go home in May, if you want that information, you will have to either come to Augusta and get in touch with the State Controller or do it by mail. I feel that the booklet is very helpful. We had it in 1951 and sessions before and for some reason last session no order was introduced to have it published. Therefore, I shall go along against the motion to indefinitely postpone.

The SPEAKER: The question before the House is on the motion of the gentleman from South Portland, Mr. Fuller, that the joint order be indefinitely postponed. The same gentleman has requested a division. As many as are in favor of the indefinite postponement of the joint order will kindly rise and remain standing in their places until the monitors have made and returned the count.

A division of the House was had.

Two having voted in the affirmative and ninety-eight having voted in the negative, the motion to indefinitely postpone the Joint Order did not prevail.

Thereupon, the Joint Order (H. P. 130) received passage and was sent up for concurrence.

ORDERED, that Rev. Charles Pendleton of Congregational Church, Bethel, be invited to officiate as Chaplain of the House on Tuesday, February 1, 1955.
