Mr. MacDonald from the House Committee on Elections on the Returns of Votes cast for Representatives to the Legislature in the several cities, towns and plantations in the State of Maine at the general election held on September 13, A. D. 1954 and subsequent Special Elections to fill vacancies as stated in communication from the Secretary of State reported the following Resolution:
