Committee Amendment "A" was read by the Clerk as follows:

COMMITTEE AMENDMENT "A" to S. P. 160, L. D. 354, Bill "An Act to Incorporate Associated Industries of Maine."

Amend said Bill by adding at the end thereof another section, to be numbered 4, and to read as follows:

'Sec. 4. Recording certificate; fees. Before commencing business the aforesaid corporation shall make and record a certificate of incorporation in accordance with section 4 of chapter 54 of the Revised Statutes of 1954, within the time limit

therein expressed and pay the fees as required by said section 4.'

Committee Amendment "A" was adopted in concurrence and the Bill assigned for third reading the next legislative day.

The SPEAKER: The Chair recognizes the gentleman from West Gardiner, Mr. Martin. For what purpose does the gentleman rise?

Mr. MARTIN: Mr. Speaker, I would like permission to address the House out of order.

The SPEAKER: The gentleman from West Gardiner, Mr. Martin, requests unanimous consent to address the House. Does the Chair hear objection? The Chair hears none and the gentleman may proceed.

Mr. MARTIN: Mr. Speaker, I am asking to take up a bill out of order. My reason is that I am betwixt wind and high water and I am on the hook and I crave your help in getting me off the hook. The bill to which I refer is Item number 25 on page 10 of today's calendar, it is Legislative Document number 485. It is an emergency bill with an amendment, filing number 39, to enable the town of West Gardiner to increase its bonded indebtedness for the purpose of creating extra rooms in the school. We are having our town meeting a week from Monday and if this bill is passed quickly enough and signed by the Governor quickly enough we can save the expense of a special town meeting.

I have made arrangements for the bill to receive its two readings in the Senate this afternoon, if we could take it up now. Therefore, I move that the rules be suspended and that this bill receive its first, second and third readings now, that it pass to be engrossed and that it be sent to the Senate forthwith.

The SPEAKER: The gentleman from West Gardiner, Mr. Martin, moves that the House at this time, take up out of order and under suspension of the rules, Item 25 under House Reports of Committees with respect to Bill "An Act relating to of Indebtedness West Gardiner School District." Does the Chair hear objection to taking up out of order at this time Item 25? The Chair hears none.

'; provided that the total number of votes cast for and against the acceptance of this act at said meeting equals or exceeds 20% of the total vote for all candidates for Governor in said town at the next previous gubernatorial election.'

Committee Amendment "A" was adopted and under suspension of the rules, on motion of Mr. Martin of West Gardiner, the Bill was given its third reading, passed to be engrossed as amended and sent to the Senate forthwith.

Mr. WINCHENPAW: Mr. Speaker and Ladies and Gentlemen of the House: I am in a very embarrassing position, today, I am in an extremely embarrassing position. Two or three days ago I asked unanimous consent to introduce a bill notwithstanding the cloture rule and in more or less of a joking mood, I was refused that privilege.

Now, today, I find myself in dire straits. The officers of the Knox Memorial Corporation in Thomaston called me yesterday on the phone and asked me if a resolve had been introduced in favor of Knox Memorial. They said: "We asked you about that last summer." "Last summer!" I said.

Now, I believe that there is nobody to blame but myself and for the last four sessions, as far as I know, this resolve has never been refused. Now Montpelier, as you probably know, is a replica of the home of General Knox in Thomaston. It is a very important historical building. General Knox was a famous Revolutionary War General from whom Knox County derives its name.

Now, Mr. Speaker, in this very embarrassing position and in a very serious mood, I request unanimous consent to introduce a resolve notwithstanding the cloture order.

The SPEAKER: The gentleman from Friendship, Mr. Winchenpaw, requests unanimous consent to introduce a resolve notwithstanding the cloture order. The Clerk will read the title of the resolve.

The CLERK: Resolve in favor of Knox Memorial Association, Inc. for Support and Maintenance of "Montpelier."
