# Thursday, March 3, 1955

The House met according to adjournment and was called to order by the Speaker.

Prayer by the Rev. Mr. Ernest Johnson of Hallowell.

The journal of the previous session was read and approved.

The SPEAKER: Senate Papers and First Reading of accompanying Bills and Resolves. Under this heading the Chair will entertain the motion as yesterday to expedite matters that the Bills and Resolves to be referred to the Committees be referred jointly in concurrence with the Senate and so that the members may study those for a minute, the Chair declares the House at ease.

# Gentlemen:

This communication is written for the purpose of inviting the Legislature to consider with me a matter which affects the interest of the State. It concerns a portion of the Marine Hospital in Portland which has been declared surplus to Federal needs.

The buildings involved are as follows: the main hospital building, the new brick power house, a new brick garage, a brick employees' quarters, and two incidental wooden buildings. These buildings are situated on a tract of land which is located in Portland between Veranda Street and the ocean.

The State may acquire this plant by gift if it is to be used for health or educational purposes. If the State acquires it for these purposes and continues to so use it for twenty years, the Federal Government will have no further claim on it. If, during that period, the use should change to a non-education or nonhealth purpose, or the State should dispose of it, the State could discharge any Federal claim by paying a pro-rated portion of the fair value to the Federal Government.

The State may acquire the property for other than health or educational purposes by purchase at the fair value price.

If the State does not wish to acquire the property, it will be sold by bids to private purchasers. It is my understanding that the City of Portland has no interest in acquiring it for any purpose.

Several uses for this plant are being considered. These uses fall into two categories.

In the first category are uses which would substitute for, supplement, or add to existing facilities, as follows:

1. To provide for overflow from Pownal State School or to provide care for a special category of Pownal patients.

2. To provide an institution for the geriatrics patients at Augusta State Hospital and thus relieve overcrowding.

3. To provide for tuberculous patients now in the State mental hospitals.

In the second category are uses which would provide new services, as follows:

1. To provide for the care of chronic alcoholics.

2. To provide both an inpatient and outpatient service for the care, and particularly for the rehabilitation, of all types of chronically ill patients, including selected alcoholics, the tuberculous patient who may no longer need specialized tuberculosis care, the arthritic, the orthopedically deformed, the paraplegics, etc.

These two lists of possible uses does not exclude other possibilities which may develop.

The present patient capacity of the hospital is about 75, but this might be increased by 20 to 25 for certain types of patients. There is ample space for the provision of outpatient services. It is estimated that it would cost more than \$1,-000,000.00 to build a comparable plant.

The cost of repair, renovation, redesign, and re-equipping the plant is estimated roughly at \$250,000.00. For certain uses, Federal funds might be available to cover up to one-half of this cost under amendments to the Hill-Burton Act.

The cost of operation and maintenance would vary, depending upon the use to which the property is put. It has been estimated roughly at \$250,000.00 per year.

A decision as to whether the State should acquire this property must be reached during this legislative session. Consultations are being held with State and Federal officials. Inasmuch as any decision to acquire the property would require legislative sanction and a legislative appropriation, I feel it is advisable at this time to give the Legislature an opportunity to participate in these consultations and to make such further inquiry as the Legislature may deem appropriate.

It is my recommendation, therefore, that this matter be referred to the appropriate legislative committee or committees for study. My services in this connection are available to the extent that they may be helpful.

Mr. WADE: Mr. Speaker and Members of the House: I would like to present House Amendment "A" to House Paper 367, Legislative Document 424, Bill "An Act to Create the Auburn Parking District."

The House Amendment is as follows: Amend said Bill by striking out the figures "\$500,000" at the end of the 1st sentence of section 6 and inserting in place thereof the figures "\$200,000".

This amendment is the result of a request on the part of the Auburn City Government through their City Manager that the amount of authorized indebtedness be reduced in this amount because it is felt by the Auburn government that the smaller amount is adequate. I hope this amendment is accepted.

Mr. ROGERSON: Mr. Speaker, the Legislative Document 1100, which is under consideration here, is somewhat unusual in that it enables the Department of Health and Welfare to spend money to reimburse hospitals outside the State of Maine, and in so far as it does that it possibly requires some explanation.

From the evidence I presented to the Appropriations Committee, it appears that in the areas adjacent to the borders of the State there are many communities where people find it necessary, because of a lack of adequate hospital facilities, to cross the State line into the State of New Hampshire or possibly into Canada, Province of New Brunswick or Quebec, and in those cases the Department of Health and Welfare feels that they would like the authority to reimburse those hospitals for treatment of Maine residents, and so this measure does allow Department of Health and Welfare to compensate hospitals located in the State of New Hampshire within five miles of the Maine border and to compensate hospitals within five miles of the Maine border if they are in the Province of Quebec or New Brunswick.

Thereupon, the Bill was passed to be engrossed and sent to the Senate.

The SPEAKER: The Chair now lays before the House the third item of unfinished business of yesterday, House Divided Report, Majority Report "Ought not to pass" and Minority Report "Ought to pass" of the House Select Committee on Reapportionment on Resolve to Apportion One Hundred and Fifty-one Representatives Among the Several Counties, Cities, Towns, Plantations and Classes in the State of Maine, House Paper 953, Legislative Document 1056, introduced by the gentleman from Houlton, Mr. Rogerson, and tabled yesterday by the same gentleman pending acceptance of either report.

The Chair recognizes the gentleman from Bridgewater, Mr. Finemore.

Mr. FINEMORE: Mr. Speaker and Members of the House: In the absence of the gentleman from Houlton, Mr. Rogerson, I will move that we now accept the "Ought not to

pass'' report, or the majority report of the committee.

The SPEAKER: The gentleman from Bridgewater, Mr. Finemore, moves that the Majority Report "Ought not to pass" be accepted. Is this the pleasure of the House?

The motion prevailed and the Majority Report "Ought not to pass" was accepted.

The SPEAKER: The House is proceeding under Orders of the Day. The Chair will now recognize the gentleman from Chelsea, Mr. Allen.

Mr. Allen of Chelsea was granted unanimous consent to address the House.

Mr. ALLEN: Mr. Speaker, as many of you know for some time I have been a little bit disturbed on Today kind ef highway matters. reached a climax of that disturbance. I attended a public hearing on these bills of increase of 1 cent on gasoline tax and on the bond issue. I intended to go on record as opposing any bond issue whatever. At that hearing I did not get a chance to express my views, whereas two previous speakers that had spoken as proponents of the measure did, they got a chance to speak again, and that disturbed me considerably.

Now to build up to this, it seemed that someone would like to use the party to sell a bond issue to the people of the State of Maine. I have heard statements to the effect that this was a Republican program and was Republican sponsored and I believe that those statements are not right, and yet we continue to hear them. Now this accelerated highway program, as I understand it, was presented to the people a while ago at previous legislatures and I believe then that the people of the State of Maine were sold a bill of goods, that this accelerated highway program to include a bond issue was something that could not be carried out even at that time. It is my firm conviction that another bond issue is trying to be sold to the people of the State of Maine and now they are just merely asking that it be provided to provide a cushion for highway needs that might come up. It does not look to me like good administration if we

can not run our department any closer than to have to have a fifteen million dollar cushion to cover us.

I would call your attention to page 303 of this Budget Document. We have there the Highway fund, Federal Aid Primary. Now to me that means a Federal Aid Primary Fund is a matching fund. Here they propose to spend \$2,105,000 on an unmatched basis. Now that \$2,000,-000 alone would be enough to make up any deficit which they claim might exist for next year to cover matching funds, so I do not believe at this time that we need a bond issue.

There were many speakers that spoke against the gasoline tax. A few gct to speak definitely against the bond issue, but the gasoline tax opponents did produce evidence that extra money was not needed and if it was not needed for extra tax then I would think that we do not need certainly a bond issue for it.

While I am speaking, on February 3, I introduced an order asking for certain information, asking the Controller to make an analysis. I think that has been distributed and placed on your desks. Many have asked me what I intended to prove by that order or what was the purpose of it. Sometime prior to that I went before the Highway Commission to discuss a few things which I felt were unfair among the bidders. One thing that I mentioned was on a lot of contracts that do have items of bituminous macadam and bituminous concrete surface courses and such. Now there are comparatively few contractors in the state that are able and capable to put on those surface courses so if the large number of small contractors wish to bid on one of those jobs they have to make some kind of an agreement with someone else and it is usually ended up with one of their larger competitors to put on or do this portion of the work for them. Now I brought this to the attenticn of the Commission and requested that they leave these items out of contracts, in other words, the contracts would be let similar to stage construction contracts whereby the first contract includes the base and the grading and then the surface work could be let under a separate contract at a later date and be done entirely separate so that one contractor does not have to go to another contractor and make any kind of agreements whatever.

Now this information showed from a spot check that we made that the contracts in the larger brackets or the jobs over \$500,000 cost the State more per unit than they did on the smaller contracts, and because the spot check probably was not accurate enough, I felt that this would show it up more specifically, which it does. Both of these things are shown here, that the large contracts cost the State more where there is lack of competition and that the surface of bituminous concrete and bituminous macadam shows up in large quantities in the small contract, so the small contractor does not get a fair break in the fact that his jobs or the brackets that he is capable of bidding on do have these items of surface in there which he cannot build. Now the reason that he cannot do that is because to get equipped to put on this type of surface it would cost approximately \$200,000 and there are none of the small boys today that are prepared or that can see their way clear to invest \$200,000 to get this kind of equipment, so there is existing an unfairness I believe. I made these views clear to the Commission. The Commission indicated that it was not part of their duties to analyze these contracts or police the contracts or to see what was going on, and I did ask the Commission if they would like to be shown and they indicated that they would, so this is the result of that meeting, and it does show very clearly what could be done to save the State money and to make bidding a little more competitive, on the highways I might indicate that there could be definitely a saving to the State if these things were eliminated. Thank you.

Mr. Fuller of South Portland was granted unanimous consent to address the House.

Mr. FULLER: Mr. Speaker and Members of the House: I want to call your attention especially to the new members of the House the Legislative Docket which is in the Clerk's Office. This Legislative Docket was started by Mrs. Regis Strout in 1933, and Mrs. Strout is still in charge of it. Legislative Docket is a misnomer in a way, it really is a Legislative Information Bureau, and I just want to cite, I have written down a few of the things that they do in there and I do not think all of the members, and especially the new members, realize all of the information that is available to us.

First, they have a record of all bills and resolves introduced in the Legislature, that is both the House and the Senate. There is a multiple index. In other words, an index of subject matter as well as titles. The date of all the Legislative hearings, they can tell you just where a bill is from the time it is introduced until it is signed by the Governor or killed. There is a complete list and a complete record of all amendments to all bills and resolves. All the action on every bill introduced in both the House and Senate, like Committee assignments, hearing dates, reports of Committees, and all of the amendments. There is a complete file for every Committee, showing all bills and which committees they are referred to. There is also a complete file for each member of the House and Senate. For instance, any member of the House or Senate might want to go and find out what bills he had introduced and the titles. You may do that.

The point I want to make is unless we, as Members, make use of all of this valuable information which is available to us, all of Mrs. Strout's work is in vain. Both Mr. Pease, our Clerk, and Mrs. Strout, welcome the use of this valuable information bureau by the Members of the Legislature, and I hope that especially the new members will make full use of this bureau.

On motion of the gentleman from York, Mr. Hancock, the House voted to take from the table the fourth tabled and unassigned matter, Bill "An Act Exempting Real and Personal Property Occupied or Used by Tax Exempt Organizations from Taxation," Senate Paper 137, Legislative Document 329, tabled on March 2 by that gentleman pending third reading.

On further motion of the same gentleman, the Bill was given its third reading, passed to be engrossed and sent to the Senate.

Mr. Carter of Newport was granted unanimous consent to address the House.

Mr. CARTER: Mr. Speaker, for the past several weeks the School Committee, Selectmen and interested town officials in the Town of Exeter have been working on plans to build a new schoolhouse. At this time I would like unanimous consent to present an Act to Incorporate the Exeter School District.

The SPEAKER: The gentleman from Newport, Mr. Carter, requests unanimous consent to introduce a bill notwithstanding the cloture order. The Clerk will read the title of the bill.

The CLERK: Bill "An Act to Incorporate the Exeter School District".

The SPEAKER: Does the Chair hear objection to the reception of this bill notwithstanding the cloture order?

The Chair hears none and the bill is received.

Thereupon, on motion of Mr. Carter of Newport, the Bill (H. P. 1058) was referred to the Committee on Legal Affairs, ordered printed and sent up for concurrence.

The SPEAKER: The House is proceeding under Orders of the Day. If there is no further business to come before the House, the Clerk will read the noilces.

The SPEAKER: There is one further item of business with relation to the order of the gentleman from Kennebunkport, Mr. Bibber. The Speaker appoints to the Joint Select Committee with relation to the Marine Hospital the following members of the House: the gentleman from Auburn, Mr. Jacobs; the gentleman from Bridgewater, Mr. Finemore; the gentlewoman from Rumford, Miss Cormier; and the gentleman from Kennebunkport, Mr. Bibber.
