STATE OF MAINE HOUSE OF REPRESENTATIVES 97th LEGISLATURE

#### JOINT RESOLUTION

Whereas the State Highway Commission transmitted to the members

of the Legislature a report on evaluation of State Aid Highways in which it outlined five plans for the administration of the State Aid Highway System; and,

WHEREAS the Joint Standing Committee on Highways after studying the report of the Highway Commission in accordance with a Joint Order passed by both branches of

the Legislature; and,

WHEREAS the Joint Standing Committee on Highways found that it was not desirable to increase the cost of maintenance or construction of Highways at the local level and would recommend to the Legislature the adoption of Plan 1 with the provision that any town which so desired might apply to the State Highway Commission for reconsideration of any part of its State Aid Highway System; now therefore

BE IT RESOLVED by the Senate and House of Representatives of the 97th Legislature after due consideration of the report and the five plans suggested therein and the recommendation of its Committee on Highways that Plan 1 should be followed by the State Highway Commission with the same provision that any town which so desires may apply for reclassification of any part of its State Aid Highway system. (H. P. 1087)

Thereupon, under suspension of the rules, the Resolution was adopted and sent up for concurrence.

Hanson, Representative from Machiasport, and a member of the House of Representatives in 1893, 1905, 1945, 1947, 1949, 1951, 1953, and 1955, and also Secretary of the Senate in 1911.

AND WHEREAS, in his association with the members of this House he was ever honorable and kindly, being highly regarded for his character and sterling qualities of mind and heart;

Mr. McGLAUFLIN: Mr. Speaker and Members of the House: I wish to speak briefly regarding Mr. Hanson.

William C. Hanson was born in Machias eighty-nine years ago. He was educated in Washington Academy. He had a varied career. At one time or another, he was a school teacher, Superintendent of Schools, a merchant, an assessor, a

Selectman, carried on an insurance business, was an assistant postmaster, a secretary of the Senate, and was elected to the State Legislature eight times.

In religion, he was a Congregationalist. In politics, he was a Democrat. I served in this House with Mr. Hanson four terms. He endeared himself to every member of the House, be he Democrat or Republican. He was a gentleman. He was fair. He had a rare sense of humor. When he talked, members listened. They respected him, they honored him. They loved him. He was elected to the Legislature by both Democrats and Republicans. He made friends wherever he went. He will be greatly missed both in Machias and in the Legislature.
