# Ought to Pass with Committee Amendment

Mr. Foss from the Committee on Agriculture on Bill "An Act relating to Time of Examination by Board of Veterinary Examiners" (H. P. 513) (L. D. 577) reported "Ought to pass" as amended by Committee Amendment "A" submitted therewith.

Report was read and accepted and the Bill read twice.

Committee Amendment "A" was read by the Clerk as follows:

COMMITTEE AMENDMENT "A" to H. F. 513, L. D. 577, Bill "An Act relating to Time of Examination by Board of Veterinary Examiners."

Amend said Bill by striking out the underlined words "and Tuesday of July at least once a year" in the 3rd line from the end and inserting in place thereof the underlined words: 'and the Tuesday following said 2nd Monday of July'

Committee Amendment "A" was adopted and the Bill assigned for third reading tomorrow.

Mrs. Thomas from the Committee on Legal Affairs on Bill "An Act to Create the Brunswick Parking Authority" (H. P. 622) (L. D. 628) reported "Ought to pass" as amended by Committee Amendment "A" submitted therewith.

Committee Amendment "A" was read by the Clerk as follows:

COMMITTEE AMENDMENT "A" to H. P. 622, L. D. 628, Bill "An Act to Create the Brunswick Parking Authority."

Amend said Bill by adding at the end of Section 4 (a), (8), the following:

'except, however, that no products used in or for the servicing of motor vehicles, other than municipally owned or operated motor vehicles, shall be sold or dispensed at or in connection with public offstreet parking facilities by the District or any lessee thereof,'

Further amend said Bill by striking out the period following the word "meeting" at the end of the last line of the 1st paragraph of the Referendum clause and insert in place thereof the following: '; provided that the total number of votes cast for and against the acceptance of this act at said meeting equals or exceeds 20 per cent of the total vote for all candidates for Governor in said town at the next previous gubernatorial election.'

Committee Amendment "A" was adopted and the Bill assigned for third reading tomorrow.

Bill "An Act relating to Jurisdiction of Cases of Forcible Entry and Detainer of Recorders of Municipal Courts" (S. P. 220) (L. D. 561)

The SPEAKER: The Chair recognizes the gentleman from Bangor, Mr. Browne.

Mr. BROWNE: Mr. Speaker, whereas the amendment which I was requested to offer at this time would amend the bill in substance, I should like to have it considered by the Committee as a whole and therefore I move now that Legislative Document 561 be recommitted to the Committee on Judiciary.

The SPEAKER: The gentleman from Bangor, Mr. Browne, moves that Item 2 under Third Readers, Bill "An Act relating to Jurisdiction of Cases of Forcible Entry and Detainer of Recorders of Municipal Courts" be recommitted to the Committee on Judiciary. Is this the pleasure of the House?

The motion prevailed and the Bill was recommitted to the Committee on Judiciary in non-concurrence and sent up for concurrence.

The SPEAKER: The Chair lays before the House the first tabled and today assigned matter, An Act Exempting Real and Personal Property Occupied or Used by Tax Exempt Organizations from Taxation, Senate Paper 137, Legislative Document 329, tabled on March 9 by the gentleman from Bowdoinham, Mr. Curtis, pending passage to be enacted.

#### House at Ease

Called to order by the Speaker. The SPEAKER: The Chair has just laid before the House the first tabled and today assigned, matter tabled by the gentleman from Bowdoinham, Mr. Curtis, pending passage to be enacted and the Chair recognizes that gentleman.

Thereupon, on motion of Mr. Curtis of Bowdoinham, Senate Paper 137, Legislative Document 329, was passed to be enacted, signed by the Speaker and sent to the Senate.

The SPEAKER: The Chair now lays before the House the second tabled and today assigned matter, Bill "An Act relating to Trapping for Bear", House Paper 413, Legislative Document 460, tabled on March 10 by the gentleman from Fairfield, Mr. Osborne, pending third reading and the Chair recognizes that gentleman.

Mr. OSBORNE: Mr. Speaker and Members of the House: The committee amended this regulation to good advantage but in reading it over I recalled an incident where I almost myself walked into a trap and I thought that possibly a further amendment would be advantageous. If I can prevent any individual from being injured or prevent their being crippled or perhaps even prevent the loss of their lives, I will feel that I have not spoken in vain.

The reason for wording this in both English and French is because, as you all know, there are a good many people working in the woods up north that possibly do not speak English and if we are going to trap any bonded Canadians, we do not want to do it with a bear trap. I do not hunt bear myself because. I will tell you, you get really cold if you hunt bear but I would like to have comments from the gentleman from Medway, Mr. Potter, on this matter because he has very thoughtfully provided us with an exhibit of what a lethal weapon this bear trap is by bringing in a cub trap and he will take up from here, I believe. Thank you.

The SPEAKER: The Chair recognizes the gentleman from Medway, Mr. Potter.

Mr. POTTER: Mr. Speaker and Members of the House: I am thoroughly in accord with this amendment which might seem to be a little far-fetched. I brought this in to demonstrate, a medium size bear trap. The full size traps are nearly one and a half times the size of this. It can only be opened with clamps, screwed down on each spring. The bear trapper sets these traps in the blueberry fields and in the apple orchards during the entire season when the bear is active, which is from April through to when snow comes in the fall. They set them around where children are picking blueberries with their parents and they set them around in the orchards where the people might stop in for a picnic in the fall and pick up a few apples. In a lot of areas we have old, abandoned The orchards. who apple man owned the apple orchard probably long since passed to his reward and they set these traps, they cover them with grass or roll them up in moss. They are entirely concealed and unless we have good protection, it is very easy for a man to get into them. In fact, there is an authentic record in our town some years ago of a man getting caught in one of these and if it had not been for a neighbor hearing him holler he probably would have been there until he died. They would break a man's

leg for sure and there is no way that he could get out of them. If he wasn't taken out, he couldn't get out. I think this bear trapping proposition whould be given all the protection we possibly can.

The SPEAKER: The Chair understands that the gentleman from Fairfield, Mr. Osborne, offers House Amendment "A" and moves its adoption. The Clerk will read House Amendment "A".

House Amendment "A" was read by the Clerk as follows:

HOUSE AMENDMENT "A" to H. P. 413, L. D. 460, Bill "An Act relating to Trapping for Bear."

Amend said Bill by striking out the last sentence thereof and inserting in place thereof the following underlined sentence:

'Said enclosure shall be marked by substantial signs with the words "BEAR TRAP" and "TRAPPE D'OURS" with letters not less than 3 inches in height, said signs to be spaced around each enclosure at intervals of not more than 20 feet and each sign securely fastened to the top strand of barbed wire.'

Thereupon, House Amendment "A" was adopted, the Bill read the third time, passed to be engrossed as amended by Committee Amendment "A" and House Amendment "A" and sent to the Senate.

The SPEAKER: The Chair lays before the House the third tabled and today assigned matter, Bill "An Act Repealing Statement of Contributions and Expenses bv Municipal Candidates", House Paper Legislative Document 196. 191. tabled on March 10 by the gentleman from Bangor, Mr. Quinn, pending third reading and the Chair recognizes that gentleman.

Mr. QUINN: Mr. Speaker and Members of the House: On the last legislative day, L. D. 196 was amended. This was "An Act Repealing Statement of Contributions and Expenses by Municipal Candidates." It was amended on the last legislative day to include inhabitants at large in cities of over 30,000 inhabitants. Because of that amendment, it became necessary to change other provisions in the act and this House Amendment "C" is to now adapt the act to meet the requirements of the amendment and I move its adoption.

The SPEAKER: The gentleman from Bangor, Mr. Quinn, offers House Amendment "C" and moves its adoption. The Clerk will read House Amendment "C".

House Amendment "C" was read by the Clerk as follows:

HOUSE AMENDMENT "C" to H. P. 191, L. D. 196, Bill "An Act Repealing Statement of Contributions and Expenses by Municipal Candidates."

Amend said Bill in the 25th and 26th lines thereof by restoring the stricken out words and punctuation to read as follows:

'or the clerk of the municipality, as the case may be,'

Further amend said Bill by striking out all of Section 2 and inserting in place thereof the following:

"Sec. 2. R. S., c. 9, Sec. 7, amended. The last sentence of section 7 of chapter 9 of the revised statutes is hereby amended to read as follows:

'The Secretary of State shall, at the expense of the State, provide every eity and town clerk of a city of over 30,000 inhabitants with blank forms suitable for the statements required to be returned to him.' "

House Amendment "C" was adopted.

The SPEAKER: The Chair recognizes the gentleman from Bangor, Mr. Quinn.

Mr. QUINN: Mr. Speaker, this morning, suggestions have been made for further amending this matter and I now move that this matter be tabled to be heard Thursday of this week.

The SPEAKER: The gentleman from Bangor, Mr. Quinn, moves that Bill "An Act Repealing Statement of Contributions and Expenses by Municipal Candidates", House Paper 191, Legislative Document 196, be again Leid on the table pending third reading and be specially assigned for Thursday, March 17. Is this the pleasure of the House?

The motion prevailed and the Bill was so tabled and assigned.

The SPEAKER: The House is continuing under Orders of the Day.

Thereupon, out of order and under suspension of the rules, Mr. Jennings of Strong presented the following Order and moved its passage: WHEREAS, the Doorkeeper of the House, Clarence P. Chase, while following his hobby of ice fishing for relaxation over the weekend, was favored with unusual luck and today has in his possession a large pickerel which he caught;

NOW, THEREFORE, BE IT OR-DERED that said Clarence P. Chase be permitted to present to the Speaker of the House for his approval and pleasure this fisherman's pride.

Thereupon, the Order received passage, amid the applause of the House.

Mr. Clarence P. Chase then came to the rostrum and presented the fish to the Speaker.

The SPEAKER: On the record, this looks like a fish.

Mr. CHASE: Mr. Speaker, in order to show my respect and the esteem in which I hold you as a friend and to show my appreciation for the excellent work you are doing as Speaker of this House, I wish to present you with this fish. I am sorry it is not larger but it is the best I could do on this trip. I caught this fish myself, as you may not believe but I did. It came from the waters of Great Pond in the Belgrade Chain of Lakes. It is 27 inches long and weighed five pounds when it came out of the water.

You know, Mr. Speaker, they say that fishermen are awful liars, or should I say some fishermen are awful liars, unless they have the credentials to prove their statements. I think on this occasion I have the proper credentials.

Now, Mr. Speaker, I hope that you and your family will enjoy eating this fish as much as I did catching it. (Applause)

(Speaker Trafton then displayed the fish to the House.)

Speaker TRAFTON: Mr. Chase certainly has a prize. I do not know whether this is offered partly because he knows of a certain other fishing trip recently which certain members of the Legislature went on and came back unsuccessful but it is a beauty. Thank you very, very much, Mr. Chase.

The Chair thinks that members of the Fish and Game Committee might well come up after the morning session is over and study this specimen.

Mr. Bibber of Kennebunkport was granted unanimous consent to address the House.

Mr. BIBBER: Mr. Speaker and Members of the House: Today commemorates the 135th birthday of the great State of Maine. I think it only fitting and proper that we as members of the 97th Legislature pay tribute to this birthday, and, for the sake of the record, I would like to read the small article that was in the paper.

"Its independence from the Commonwealth of Massachusetts became complete on March 15, 1820, eight days after the separation act had been signed by President James Monroe. The reason for the separation act was that the northern states needed the creation of a state to preserve the balance of power with the southern states due to the Missouri Compromise. State records show that Portland, Augusta, Hallowell, Brunswick, Wiscasset, Belfast and Waterville made bids to be the permanent capital but Augusta was finally selected in 1827. Bangor was rejected because it was too vulnerable to enemy attack according to the reports of that day.'

I think it only fitting and proper that on this day we stand and pay tribute to the State of Maine and to those great people who have made it one of the finest states in the Nation.

Thereupon, the members of the House rose and remained standing for a moment in silent tribute.

The SPEAKER: The House is proceeding under Orders of the Day.
