It would make a much cleaner looking record, it would help our reporters very much indeed, if we made it a rule to table any report or bill about which we wish to make a motion and take it from the table and have the discussion after all the bills have been reported—in other words under Orders of the Day. If we keep making motions and having debate during the course of the reading of these bills, we will clutter up the reports of the session. We would do much better I think if we waited until Orders of the Day to make our motions and have our debate. Thank you.

#### STATE OF MAINE OFFICE OF THE GOVERNOR Augusta

The Honorable Speaker of the House

Ninety-eighth Legislature

There will be presented to the Legislature today a resolve relating to the Hungarian refugee problem. I would like to take this opportunity to say a few words with reference to it.

You are all aware of the recent events in Hungary which have brought thousands of freedom-loving citizens of that unfortunate land to our shores. It is national policy, as declared by the President, as well as simple humanity, that all Americans apply themselves to the problem of finding a place in our midst where these people can find work and establish homes.

It is a heart-warming fact that many citizens in our state have voluntarily and spontaneously rallied their forces to this task. Private agencies are applying their resources to the problem. The Red Cross, the International Rescue Committee, and resettlement services of various church groups are raising funds and doing a great deal of the work.

A meeting of representatives of these agencies, of legislative leaders, appropriate state department heads, and private citizens was held at the Blaine House last week. It was agreed that there was need to coordinate all of the foregoing efforts and to rally public support for a comprehensive program. It was felt that a Governor's Committee on Refugee Resettlement would serve these purposes. The resolve which will be presented to you today will give legislative endorsement to this proposal.

Funds are needed only to provide minimum secretarial staff. Other funds which may be required for relief or similar purposes will be raised through private sources or by public subscription.

The objective of the coordinated effort will be to find places for Hungarian refugees in Maine consistent with their talents to the extent that can be done without, of course, displacing our own citizens. The numbers involved will probably be relatively limited, although unpredictable at the present time. The Governor's Committee will not be involved in the actual work of resettlement, but will serve simply as a means of coordinating the efforts of the operating agencies.

The resolve has my support, and I commend it to your attention.

Mr. LOW of Knox: Mr. President, in order to implement the suggestions of the Governor, I move that the rules be suspended for the purpose of introducing the resolve.

The motion prevailed and under suspension of the rules Mr. Low of Knox presented Resolve to Aid Settlement of Hungarian Refugees in Maine (S. P. 110)

Mr. LOW of Knox: Mr. President, this is a resolve to appropriate five thousand dollars from the unappropriated surplus for the purpose of paying for the expenses of the committee and the Governor's staff in working out the resettlement of Hungarian refugees. I am sure we are all in favor of it. I move that the rules be suspended and that the resolve be passed to be engrossed without reference to a committee.

The motion prevailed and under suspension of the rules, without reference to a committee, the resolve was given its two several readings and passed to be engrossed.

Sent forthwith to the House for concurrence.

Under suspension of the rules, Mr. Sinclair of Somerset presented bill, "An Act Relating to Payment of Salaries of Members of the Legislature" (S. P. 111)

Mr. SINCLAIR of Somerset: Mr. President and members of the Senate, this is a bill relating to the payment of salaries to members of the legislature.

As many of you know, the statutes call for payment to be made to the various members of the Legislature on the basis of \$100 per month, the balance to be taken care of at the end of the session. This bill will merely make it legal for the process we are now using to be carried out, whereby we are paying \$125 bi-monthly. I move that this bill be given its two readings without reference to a committee.

The motion prevailed and under suspension of the rules, the bill was given its two several readings without reference to a committee, and passed to be engrossed.

Sent forthwith to the House for concurrence.

PRESIDENT: The The Chair would note that no member of this legislature will be asked to vote on the question of enactment of either the resolve or the bill just received, until each has been printed. It would normally be printed tonight, and both the resolve and the bill should be on your books tomorrow before the enactment stage.

Mr. LOW of Knox: Mr. President and members of the Senate, I am informed by the House Floor Leader that there will be a school tonight for new members of the House and Senate and it will be addressed by our Honorable President on budget matters. All members of the Senate are cordially invited to attend.

The PRESIDENT: The Chair would remind the Senate of the Senate Order passed in the last legislative week, wherein the Citizens Committee studying PAS report was granted the use of the

Senate Chamber this afternoon.

On motion by Mr. Parker of Piscataquis

Adjourned until tomorrow morning at ten o'clock.
