#### SENATE

Tuesday, February 12, 1957

Senate called to order by the President.

Prayer by Captain Ash of the Salvation Army, Augusta.

On motion by Mr. Hillman of Penobscot, Journal of Thursday, February 7, read and approved.

#### Orders of the Day

Mr. Woodcock of Penobscot was granted unanimous consent to address the Senate.

Mr. WOODCOCK: Mr. President and members of the Senate: It is fitting and proper, it seems to me, today that we pause to remember the life and greatness of him whom we honor today, and to this end I should like to read to you two items, the first of which appears in this morning's edition of the Bangor Daily News and is entitled "Lincoln the Philosopher."

"Abraham Lincoln's greatness is reflected in his words as well as his deeds. Well known to all Americans is his stirring Gettysburg address. Equally lasting are portions of his second inaugural address, particularly: 'with malice toward none, with charity for all; with firmness in the right, as God gives us to see the right.'

But all through his life Lincoln spun threads of philosophy. He understood the virtues and frailties of human nature, including his own. He set them forth plainly from time to time. Here are a few:

'Why should there not be a patient confidence in the ultimate justice of the people? Is there any better or equal hope in the world?'

'As I would not be a slave, so I would not be a master. This expresses my idea of democracy. Whatever differs from this, to the extent of the difference is no democracy.'

'It is difficult to make a man miserable while he feels he is worthy of himself and claims kindred to the great God who made him.'

'I shall try to correct errors where shown to be errors, and I shall adopt new views as fast as they shall appear to be true views.'

'Truth is generally the best vindication against slander.'

'Friend, the Lord prefers commonlooking people. That is the reason he makes so many of them.'

These are neat kernels of humor and humility, of wisdom and faith. They explain why Abe Lincoln comes as close to being immortal as any mortal can."

In closing these brief remarks concerning one of the truly great spirits of all time and who now does belong to the ages, I should like to read to you the letter he wrote to a mother who had lost sons in the Civil War. In style and beauty of expression, as well as in depth of feeling, this is one of the finest expressions in all the history of literature.

"Executive Mansion,

Washington, November 21, 1864 To Mrs. Bixby, Boston, Mass.

Dear Madam:

I have been shown in the files of the War Department a statement of the Adjutant General of Massachusetts that you are the mother of five sons who have died gloriously on the field of battle. I feel how weak and fruitless must be any word of mine which should attempt to beguile you from a grief of loss so overwhelming. But I cannot refrain from tendering you the consolation that may be found in the thanks of the republic they died to save. I pray that our Heavenly Father may assuage the anguish of your bereavement and may leave you only the cherished memory of the loved and lost, and the solemn pride that must be yours to have laid so costly a sacrifice upon the altar of freedom.

Mr. Silsby of Hancock presented the following order:

ORDERED, the House concurring, that:

WHEREAS, the Ninety-eighth Legislature indicates its pleasure and desire that the alterations presently being carried on in the State House be of such a nature that the beauty and dignity of the State House shall be maintained, and

WHEREAS, consistent with the above expressed desire, the Ninetyeighth Legislature believes that the installation of 'smoke doors' on the second and third floors of the State House would substantially mar the dignity and beauty of the building, and

WHEREAS, for over a century the State House has properly functioned, without such "smoke doors," even though space was inadequate to properly care for State employees permanently housed in the building, and installation of such smoke doors after the passage of over a hundred years, and after relocation of numerous employees in the new State Office Building, seems to be a gesture, having little or no justification, be it therefore

ORDERED, that the Governor and Council, the Superintendent of Public Buildings, and the Insurance Commissioner be advised that it is the recommendation of the Ninetyeighth Legislature that the aforementioned "smoke doors" not be installed on the second and third floors of the State House.

It is hereby directed that copies of this Order be sent to the Governor, the Executive Council, the Superintendent of Public Buildings, and the Insurance Commissioner.

Mr. SILSBY of Hancock: Mr. President and members of the Senate, some three weeks ago, I believe you listened patiently to me in my discourse in the matter of opposition to the smoke doors being installed on this third floor and on the second floor, and as a result of my investigation at that time and subsequently followed up with a further investigation, I feel rather duty bound to inform you that I have in no particular any criticisms to offer in behalf of the Governor and Council or the Insurance Commissioner or any of his deputies but for your informa-tion, I did find through good authority that there was some question as to what repairs or alterations should be made to this building after the employees of various offices moved over to the other building. Architects were consulted and plans were drafted, and architects being rather technical did recommend so called smoke doors and the Governor and Council and others in charge did not feel that it was within their jurisdiction to eliminate the fire doors or smoke doors; that it was wholly the problem of this legislature.

That in substance is what my further investigation has been and I want to say to you members of the Senate that with the Order I have presented, two things can be done: One, it can be sent to a committee for further investigation, or a motion would be in order for its passage. I thank you.

Thereupon, on motion by Mr. Reed of Aroostook, the Order received a passage.

Sent down for concurrence.

The PRESIDENT: The Chair notes only two Senate absentees on this legislative day and would hope again that unless some member now present knows for certain that he cannot be here tomorrow, that we may again try to have our Senate picture tomorrow. Does any Senator know that he will not be here tomorrow?

If not, the Chair will designate the Senator from Washington, Senator Wyman to see that his colleague knows of our hopes, and the Chair would designate the Senator from Cumberland, Senator Lord to notify the missing Senator from Cumberland of our hopes for tomorrow.

The Chair also welcomes back the Senator from Androscoggin, Senator Boucher and hopes that his recovery is complete.
