Wednesday, February 13, 1957

Senate called to order by the President.

Prayer by Rev. Sartell Moore of Gardiner.

On motion by Mr. Hurley of Kennebec, Journal of yesterday read and approved.

The PRESIDENT: The Chair would remind the Senate that all of us are acquainted with Reed's Rules and we are acquainted with other parliamentary procedure, but in the mid-forties there came to this Legislature a young man who set such precedents and accomplished such perfection that presiding officers have since been referring to the way George Varney did it rather than the way Reed would have it. I note that distinguished citizen from York in the Senate Chamber, and I would ask the Sergeant-at-Arms to compliment the Senate by escorting to the rostrum the former President of the Senate and probably its most distinguished President. the George Varney.

Having seated the Senate, I think it would be unfair if we did not ask George Varney to address us.
