The PRESIDENT: Referring to that section of the calendar where reference is made to Joint Order (H. P. 43), the cloture order, the Chair would note that prior to the imposition of cloture with respect to both private and special and public laws that some senators may have taken from the office of the Revisor of Statutes certain bills and may not have placed those bills in the hopper. The Chair would note that under the Joint Order the Revisor of Statutes is required to file lists of bills still in his office and not yet completed. That would rather automatically exclude and impose unanimous consent on any bills that are still in senator's pockets. If such bills are in your desks or in your pockets and if they do have the endorsement of the Director of Legislative Research on them, it is the Chair's impression that the Director of Legislative Research will not file his list until four o'clock this afternoon. It is also the Chair's impression that if those bills are taken in there the Director of Legislative Research may include them on his list. Such action will preclude the difficulty of adjudicating the question wherein a senator states in honesty and fairness that he had a bill before cloture, did not put it in, and yet the order itself would clearly indicate that the bill would be under the unanimous consent restriction if not put in. Thus if any senator has such a bill, it is suggested that the Senator disclose that fact to the Revisor of Statutes.

D. 37) tabled by that Senator on February 14 pending final passage; and on further motion by the same Senator, the resolve was finally passed.

On motion by Mr. Lessard of Androscoggin, the Senate voted to take from the table "Resolve Relating to Sale and Distribution of Index to

Private and Special Laws" (S. P. 36) (L. D. 38) tabled by that Senator on February 14 pending final passage; and on further motion by the same Senator, the resolve was finally passed.

On motion by Mr. Lessard of Androscoggin, the Senate voted to take from the table bill, "An Act Regulating Traffic by Council of Town of Bar Harbor" (S. P. 37) (L. D. 39) tabled by that Senator on February 14 pending passage to be enacted.

This being an Emergency Measure, a division of the Senate was had.

Thirty having voted in the affirmative, the bill was passed to be enacted.

On motion by Mr. Lessard of Androscoggin, the Senate voted to take from the table Bill, "An Act Relating to Indebtedness of Dover-Foxeroft School District." (H. P. 51) (L. D. 73) tabled by that Senator on February 14 pending passage to be enacted.

This being an Emergency Measure, a division of the Senate was had.

Thirty having voted in the affirmative, the bill was passed to be enacted.

On motion by Mr. Bailey of Sagadahoc, the Senate voted to take from the table bill, "An Act Relating to Milk Commission Membership" (H. P. 331) (L. D. 416) tabled by that Senator on February 7 pending reference to a committee; and on further motion by the same Senator, the bill was referred to the Committee on State Government in concurrence.
