Mrs. LORD: Mr. President and members of the Senate: I believe it is very fitting that we should pause briefly to pay honor to the greatest and most beloved American poet, Henry Wadsworth Longfellow.

He was born in Portland, February 27, 1807, just one hundred and

fifty years ago today.

On the site of the house where he was born a monument is being dedicated today by the International Longfellow Society, in the form of a large boulder from the farm of the Wadsworth family in Hiram, with a

suitable plaque attached.

The house was razed this past summer. The birth-room was preserved and has been given to Bowdoin College by the International Longfellow Society. This room will be reconstructed in some building on the Bowdoin Campus. It is very fitting that this should be done, because we all know that Longfellow attended Bowdoin College and was also a professor there for some years.

I am quoting from an Anthology of New England Poets:

"Longfellow has been alternately overpraised and belittled for the very characteristics which made him America's favorite household poet. The characterization is not undeserved, for the author "Paul Revere's Ride," "The Village "Evangeline," Blacksmith," "Hiawatha" always was, and still remains, close to the heart of his country. Nor is his reputation confined to his own land. Throughout the world, more people are more familiar with Longfellow than with any other American poet."

And to quote briefly from an editorial in this morning's Press Herald:

"Many newspapers and magazines have been carrying material and pictures relating to the poet; and no doubt exercises in many or most of the schools of the Country-especially, of course, of the schools of the poet's native State—are celebrating this natal day with enthusiasm and devotion. No longer, to be sure, are Longfellow's poems read in the family circle under the evening lamps, family circles and reading aloud are no more. But it could be that the emphasis this year, today, upon Longfellow, the poet, may send many an adult reader to his poems, there to find a forgotten pleasure in the simple verse which everybody can understand. That might be good for the people who have lost interest in poetry of such moderns as T. S. Eliot.'

I should like to close by reading the last stanza of the poem "The Building of the Ship":

"Thou, too, sail on, O Ship of State! Sail on, O Union, strong and great! Humanity with all its fears,

With all the hopes of future years, Is hanging breathless on thy fate! We know what Master laid thy keel.

What Workmen wrought thy ribs of steel.

Who made each mast, and sail, and rope,

What anvils rang, what hammers beat,

In what a forge and what a heat Were shaped the anchors of thy hope!

Fear not each sudden sound and shock.

'Tis of the wave and not the rock: 'Tis but the flapping of the sail, And not a rent made by the gale! In spite of rock and tempest's roar, In spite of false lights on the shore, Sail on, nor fear to breast the sea! Our hearts, our hopes, are all with thee.

Our hearts, our hopes, our prayers, our tears,

Our faith triumphant o'er our fears, Are all with thee,—are all with thee!"

The Chair laid before the Senate, the first tabled and especially assigned matter being Senate Report "Ought Not to pass" from the Committee on Taxation on Bill, "An Act Directing Public Utilities to File Schedule of Property Valuation with Municipal Assessors." (S. P. 187) (L. D. 466) tabled on February 26 by the Senator from Knox, Senator Low, pending acceptance of the report; and on further motion by the same Senator, the ought not to pass report was accepted.

Sent down for concurrence.

On motion by Mr. Bailey of Sagadahoc, the Senate voted to take from the table House Report "Ought to pass" from the Committee on Public Health on Bill, "An Act Relating to Depositing Carcass of Domestic Fowl to Cause Nuisance." (H. P. 289) (L. D. 385) tabled by that Senator on February 21 pending consideration of House Amendment B: and on further motion by the same Senator, House Amendment B was adopted, and the bill as amended was tomorrow assigned for second reading.

Mr. Low of Knox was granted unanimous consent to address the Senate.

Mr. LOW: Mr. President and members of the Senate: It now seems that the bill to supplement the Jacobs' Report, sponsored by the Senator from Somerset, Senator Sinclair, will be printed by next Tuesday. This is a long bill and does a great deal to reorganize the entire educational set-up in the towns. It seems worth while to have a joint meeting of the House and

Senate to explain the various provisions of this bill, and it is planned to do so next Tuesday evening. Members of the Department who have been instrumental in writing a good deal of the bill will be there; the Commissioner of Education will be there; and the Governor has indicated that he would like to attend if possible. The bill is so long and so involved that it really seems worthwhile to discuss it. I hope that all the members who can will be there on Tuesday night.

The PRESIDENT: The Chair at this time notes in the Senate Chamber a group of youngsters from the 7th and 8th grades of Garland Junior High School of Bangor, members of the Jewish Community Center. We appreciate your visiting with us and I commend to you particularly, the two able Senators from Penobscot, Senators Woodcock and Hillman who will be more than pleased to serve as both your hosts and guides wherever you want to go in the statehouse. Thank you for coming.

The PRESIDENT: The Chair would note that the next legislative day is the only day of the session when absences can be accounted for only by unanimous consent. The Chair would ask the Senate to take his word that we want to have a full attendance the next legislative day.
