Thursday, February 28, 1957

# Orders of the Day

The PRESIDENT: The Chair at this time would ask if there is objection to his inviting our honored Secretary to join him at the rostrum? The Chair hears no objection.

I think I need not introduce to the Senate your attractive guest to the left of the rosrum. Irene Woodworth is known to the many of us who have been here at least a few sessions. We have known her charming personality and have enjoyed working with her. (Applause)

It certainly is no news that the Chair at this time recognizes the Senator from Knox, Senator Low.

Mr. LOW of Knox: Mr. President, it is not too often that every single member of the Senate joins in any one action with complete enthusiasm, but we do so today, Irene and Chester, in wishing you many happy years of married life together. So that you won't forget the day, we are presenting you with a small gift. The love and respect that go with it are very large indeed. We wish you many happy years filled with health and prosperity and good luck. (Applause)

The PRESIDENT: It is now a distinct honor for the three of us up here to note the presence in the Chamber, of His Excellency, Governor Muskie and his Executive Council.

Governor Muskie was then escorted to the rostrum amid the applause of the Senate.

GOVERNOR MUSKIE: "Chet" and Irene, in behalf of the Executive Council and myself I would like to make our contribution to your day of happiness, but I won't hand it over to you until I have made a few choice comments.

I understand that this is a part of a silver service for twelve, and I can only suggest a note of optimism which appears to be implicit in the size of the gift which I hope will be warranted by events in the next few years.

As for you, "Chet," I would like first of all to raise a question out of

curiosity. I am told that when a man has nothing to worry about he gets married. Now I hope, in order that you may preserve that peace of mind, that you will always remember that women were made to be loved and not to be understood. And may I say to you also, "Chet," that when a married man wishes to have the last word it is well for him to remember that his chances are best if he uses only the word "Yes." And then I would like to note a parallel here from my own experience. I am not going to divulge your ages, which I happen to know but I happen to know there is a difference of thirteen years. Mr. LORIN ARNOLD: "Chet," we newspapermen who cover the Legislature are very happy to have the opportunity to participate in this occasion and I and they want to wish you and Irene the best of happiness and success. (Applause)

The PRESIDENT: And now the dean of all of us, a legislative agent who has been here, he says, going on sixty years, "Tom" Weeks. (Applause)

Mr. THOMAS N. WEEKS: Irene and "Chet," I am delighted and highly honored to have been selected to perform this little function for the "Third House." You have both worked with us and for us and have helped us tremendously all through my time here. Our debt to you is one we cannot pay in any coin of any realm on any reckoning day. We wish for you the best of everything. We want you to remember there are two births: one when life first strikes the newly-awakened senses and the other when two souls

unite. We must count our life from thence. (Applause)

The PRESIDENT: And now we will be honored up here by the presence of the coordinator of the two legislative branches, Mrs. Regis Strout.

Mrs. REGIS STROUT: Mr. President, I am charged with a message from the Clerk of that unmentionable Body at the other end of the corridor, and his office staff that they heartily concur in the purposes of this occasion and extend to you, Irene and "Chet," their very best and sincere wishes for many happy years together. (Applause)

The PRESIDENT: Now will one of our attractive Pages, or two of our attractive Pages come forward?

The Senate Pages, Mrs. Lois Beauchaine and Mrs. Ruth Foster approached the rostrum.

Mrs. FOSTER: Irene and "Chet," we are not the speech-makers that you have been listening to, but we want to add our little gift on behalf of the Staff and Officers of the Senate. Lots of love and happiness to both of you.

Mrs. IRENE WOODWORTH: Oh, I don't know which one to open!

First of all, Your Excellency, members of the Honorable Senate. and House members, and last but not least, Mr. President, who have all been so good to me, please accept my heartfelt thanks. I cannot tell you, words would be inadequate. I cannot find the right words. but please be assured that I will forever hold the dearest remembrance of this occasion. I am also confident that I speak for "Chet" when I say we shall cherish this forever. I thank you from the bottom of my heart. You are wonderful! (Applause)

The PRESIDENT: The Senator from Knox, Senator Low, now moves that the Senate adjourn to 10:00 a.m. Tuesday next, and before the gavel comes down the Chair will note a suspicion that "Chet" and Irene will stand down here and will be very happy if you will come down and shake hands with them.
