Mr. LESSARD of Androscoggin: Mr. President, I rise to ask unanimous consent to introduce a bill, and I would like to make a brief statement inasmuch as I realize it is a late date to ask the Senate for that courtesy.

This bill is an amendment to an act prohibiting the pauperizing of families of veterans. Up to now the word "family" has been construed to mean a soldier, sailor, marine, his wife and children. However, the Attorney General's department had occasion to make a ruling and said that would not apply if the veteran died, that is it would not apply to the widow or children.

This bill is for the purpose of amending the law so that it will provide that widows and children also cannot be pauperized.

Thereupon, bill, "An Act Prohibiting the Pauperizing of Families of Veterans" was received by unanimous consent; and on motion by the same Senator, the bill was referred to the Committee on Veterans Affairs and ordered printed.
