Senate Amendment "A" was read by the Secretary as follows: Senate Amendment "A", Additional. Sec. 3. R. S., c. 100, P. 148-A, additional. Chapter 100 of the Revised Statutes is hereby amended by adding thereto a new section, to be numbered 148-A, to read as follows:

'Sec. 148-A. Method of payment of fee for placement. If placement fee is paid weekly, 1-6 of such fee shall be paid each week for the first 6 weeks of employment; if paid semi-monthly, 1-3 of the fee shall be paid for the first 3 paydays; if paid monthly ½ of the fee shall be paid for the first 2 paydays.'

Senate Amendment "A" was adopted, and the bill was assigned

for second reading on the next legislative day.
