#### Resolve Received by Unanimous Consent

Mr. Martin of Kennebec presented "Resolve Authorizing Aeronautics Commission to Conduct an Augusta-Waterville Airport Survey." (S. P. 536)

Mr. MARTIN of Kennebec: Mr. President and members of the Senate: Very briefly, as most of you have on your desks letters from the Mayors of Augusta and Waterville, I would like to say that this is a resolve asking for an appropriation of \$15,000 to be made for a study of two or more possible sites for the location of an airport between the two cities. We find that the airports in both cities cannot be enlarged and therefore we suffer both from lack of adequate passenger service and freight service. We feel that the study is necessary. and that is what this resolve calls for. I hope this resolve may be introduced.

Thereupon, the resolve was received by unanimous consent, referred to the Committee on Appropriations and Financial Affairs and ordered printed.
