SENATE

Friday, April 26, 1957 Senate called to order by the President.

Prayer by Rev. Victor P. Musk of Augusta.

On motion by Mr. Farley of York, Journal of yesterday read and approved.

On motion by Mr. Low of Knox, out of order and under suspension of the rules:

ORDERED, the House concurring, that when the Senate and House adjourn, they adjourn to meet on Tuesday, April 30, in the forenoon. (S. P. 542)

Orders of the Day

LOW: Mr. President and Mr. members of the Senate: As of this morning there were still in committee 383 bills.
