D. 574) tabled by that Senator on May 9 pending consideration of the reports; and on further motion by the same Senator, the bill was recommitted to the Committee on Inland Fisheries and Game and sent forthwith to the House.

On motion by Mr. Boucher of Androscoggin, the Senate voted to take from the table bill, "An Act Relating to Employer's Contribution Rate Under Employment Security Law." (H. P. 815) (L. D. 158) tabled by that Senator earlier in today's session; and on further motion by the same Senator, the bill was passed to be enacted. On motion by Mr. Boucher of Androscoggin, the Senate voted to take from the table bill, "An Act to Increase Clerk Hire for Probation Officers." (H. P. 1008) (L. D. 1434) tabled by that Senator earlier in today's session pending passage to be enacted; and on further motion by the same Senator, the bill was passed to be enacted.

On motion by Mr. Boucher of Androscoggin, the Senate voted to take from the table bill, "An Act Relating to Countersignature by Resident Agents on Insurance Policies." (H. P. 1072) (L. D. 1539) tabled by that Senator earlier in today's session pending passage to be enacted; and on further motion by the same Senator, the bill was passed to be enacted.

On motion by Mr. Butler of Franklin, the Senate voted to reconsider its action taken earlier in today's session whereby it passed to be engrossed, bill, "An Act Relating to Time Limitations for Filing Petitions Under Workmen's Compensation Act." (S. P. 249) (L. D. 697); and on further motion by the same Senator, the bill was laid upon the table pending passage to be engrossed (as amended by Senate Amendment A in non-concurrence.)

On motion by Mr. Woodcock of Penobscot, the Senate voted to take from the table Senate Report from the Committee on Judiciary: Ought to pass in new draft under same title on bill, "An Act Relating to Beneficial Devices, Bequests and Legacies to Subscribing Witnesses," (S. P. 303) (L. D. 809) tabled by that Senator on May 9 pending consideration of the report; and on further motion by the same Senator, the ought to pass in new draft report was accepted and the bill read once; and the same Senator presented Senate Amendment A and moved its adoption.

Which amendment was read and adopted and under suspension of the rules, the bill was given its second reading and passed to be engrossed as amended by Senate Amendment A.

Sent down for concurrence.

Mr. Martin of Kennebec was granted unanimous consent to take from the table bill, "An Act Authorizing Sunset Real Estate Corporation to Construct a Bridge Across Medomak River." (H. P. (L. D. 601) which bill and 424)accompanying reports were tabled by that Senator earlier in today's session pending motion by Mr. Butler of Franklin to accept the minority report and were especially assigned for Tuesday next.

Mr. Martin moved the pending question.

The PRESIDENT: The question before the Senate is on the motion of the Senator from Franklin, Senator Butler, that the Senate accept the minority ought to pass report in concurrence.

Thereupon, the minority report was accepted in concurrence and the bill read once; House Amendment B was read and adopted in concurrence and the bill tomorrow assigned for second reading.
