Mr. Martin of Kennebec was granted unanimous consent to address the Senate:

Mr. MARTIN of Kennebec: Mr. President and members of the Senate, as you probably read in the papers, next Wednesday night is the start of the legislative assemblies so-called. They will start next week and be run every two weeks thereafter for seven consecutive dances. The tickets at the present time are not printed, although they will be here Tuesday. As the older members know, the sale of tickets is on a voluntary basis. You pay five dollars which includes yourself and a dancing partner for the series of dances. The proceeds are used to pay for the dances and at the end, if the Presiding Officer and other members of the staff behave themselves they are usually recognized with an appropriate gift.

I would like to point out to the Senate that the tickets are nontransferable. The citizens of Augusta give the first three dances and if we as legislators give our tickets to citizens outside of this group it means they are not able to raise sufficient funds to pay for their dances, so I would hope that the Senators will conform to the rule of using the tickets themselves and not giving them to outsiders. These tickets will be distributed next Tuesday.

#### Orders of the Day

PRESIDENT: Chair The The would like to take advantage of this relatively brief session to make a few general comments regarding Senate procedure and some of the items under our rules. I am sure all of you probably know that the Registers are now out and there is a great deal of information in this booklet. I would recommend that all of us spend some worthwhile time in going over these rules. For the benefit of some of our new members I am going to make a few brief comments on some of the things I know will be of importance later.

Under Rule 4, I think it is quite important during debate which will, of course, come up in the future that when you refer to another Senator in your debate, this rule calls for addressing him by title and county of residence. This has always been observed in the Senate and I think makes for a fine traditional procedure.

Something that is very important to be cognizant about is voting. This is very important and should be clearly understood. I have noted down that you probably have four different methods here. Ordinarily if the Chair feels that the decision of the Senate will be unanimous he will strike the gavel and unanimous ly declare the vote. I will, of course, survey the Senate to see if there are any dissenting opinions, and of course will be happy to recognize anybody who does have a dissenting opinion on the matter in question.

Secondly, we will use the voice vote, and the Chair will try to determine by the Yeas and Nays what the decision of the Senate is. If there is any question, the Chair will of course, call for a division. I would like to emphasize that at any time a Senator may request a division. It is not necessary to have a vote on it, the Senator simply stands up and addresses the Chair and informs the Chair that he would like a division on that particular item under consideration and he certainly will have that division and the Senators will be counted by the Secretary, and the Chair will determine the feeling on that particular vote.

I might also mention that we have the roll-call which can be put into effect at any time by a vote of onefifth of the members present and the Senators will be called alphabetically. The Secretary and the Assistant Secretary have the names that we can use on those various occasions.

Also Rule 10 refers to unlimited debate which is the rule of the Senate. One thing I would mention is the fact that I will not recognize, not knowingly at least, any Senator twice to the exclusion of another Senator. It simply means that you may speak more than once and it will be the Chair's responsibility to see that every other Senator has an opportunity to be heard on the particular decision which is going to be made on the question before the Senate. I think that is quite important, and, if recognized in spirit, it will work in a very comfortable degree toward efficiency in the operation of the Senate.

The tabling motion, which will soon be taken advantage of, is more or less a matter of courtesy and there are many different merits in using it. It has generally been accepted here as a matter of courtesy in the Senate and we find it has worked in the past effectively. If you want to table an item, table it and check with the Senator who may have an interest in it. We find that by using Senate courtesy it works very fine and it is a precedent which has been well established and well taken and will help make our work more comfortable here in the Senate during this session.

As we proceed on in this session there are certainly going to be many controversial issues which are going to be debated and votes taken. I think by just using this Senate courtesy it is going to work to the advantage of all the Senators here, so, when we conclude the session we will have settled our differences and each one will have felt that it has been a fair session and everybody has had a full opportunity to explain his views, and I certainly hope and will make every effort as President of the Senate to preside in a manner that will give everyone an equal and a fair opportunity.

I hope you will accept these things in the spirit in which they are given. I just mention them so that you will have some knowledge of the rules and the way that matters in the Senate will be handled.
