Senate Committee Reports

The Committee on Judiciary on a Petition of Robert H. Mottram to the 99th Maine State Legislature filed under Article 1, Section 15 of the State Censtitution. (S. P. 65) reported as follows:

This Legislature recognizes the right of the petitioner in presenting his petition. Under our Constitution our Government is divided in three branches, the Executive, the Legislative and the Judicial. The lack or want of due process of law is entirely within the province of the Judicial branch of our Government.

Until that branch has adjudicated a lack or want of due process, it is unconstitutional for the Legislative branch to either accept or reject the proyer called for in the petition. Accordingly, the petition is declined.

D. 304, H. P. 213, entitled "An Act Relating to Local Option," concerning a certain liquor question.

Now you all know that this Committee on Natural Resources has to deal with quite a few problems relating to pollution during the course of the session, but I am not sure that this is one that would properly be within the bounds of the committee. I thought it would be worth

while to call that to the attention of the other members. Thank you.
