# Orders of the Day

Mr. WEEKS of Cumberland: Mr. President, it just came to my attention that there is another bill which was introduced today which deals with the same section of the statutes and therefore I request that this bill be laid upon the table.

The motion prevailed and the bill was laid upon the table pending assignment for second reading.

Mr. WOODCOCK of Penobscot: Mr. President and members of the Senate: It is fitting and proper that we pause here today to honor the one hundred and fiftieth anniversary of the birth of Abraham Lincoln. We do so by means of a short formal comment by some of the members of the Senate. We are hereby, as we all so well know, speaking of a figure whose influence on the affairs of men down through the years has been of truly heroic proportions. For my own part of this matter, I would just like to read to you one page of an address on Abraham Lincoln made by a Maine man who in his own right was a man of great distinction, the late William R. Pattangall:

"Abraham Lincoln is a unique figure in history. A lover of peace, his name is indissolubly linked with the story of a great war; as nearly a non-partisan as any man can be who takes an active and serious part in politics; he is revered as the real founder of a great party. Elected to high office on a sectional issue and by the votes of a minority, his memory is revered in every hamlet in the country and he has become the ideal of every American who possesses high ideals.

"Trusted and loved in his lifetime by those who knew him, reviled and bitterly assailed by those who failed to comprehend the simple majesty of his character and the broad scope of his wisdom, the passage of time has led all men to do him justice and today he stands, and will stand forever, the best example of the highest type of man.

"His was a many-sided nature. Almost a mystic, he professed no religion. A great reformer, he advocated few changes in the laws and none in the constitution. A splendid lawyer, he brushed the technicalities of precedent aside and blazed new paths over ground which no man ever trod before and made the way so plain that the most timid might safely follow him. A lover and defender of the common people, he never wrote or uttered a demagogic word. A respecter of property rights, he catered not to wealth. A student, he never yielded to tradition. A writer, whose pure and limpid style is only equalled in the finer portions of the King James translation of the Scriptures, he wrote but little and that when necessary and never for effect. An orator whose eloquence and logic is unmatched, he spoke but seldom. A great man, yet devoid of all the foibles and follies which so nearly always accompany greatness."

It is this brief tribute which I would like to place on the record in memoriam of Abraham Lincoln.

Mrs. LORD of Cumberland: Mr. President and members of the Senate; I would like to quote briefly from an article by Allan Nevins:

"His statue stands in many cities; his writings are in all collections of the classics of the English tongue; his sayings are alike the treasure of the humbler and the inspiration of the great. The Hindu student, the South African Negro, the British statesman, the Latin-American publicist, find his name what Lord Charnwood called it, 'the greatest among those associated with the cause of popular government.' He belongs equally to the masters of statecraft and to plain men and women."

Now I would like to quote briefly from some of his works:

"As I would not be a slave, so I would not be a master. This expresses my idea of democracy. Whatever differs from this, to the extent of the difference, is no democracy."

"Let us have faith that right makes might; and in that faith let us to the end, dare to do our duty as we understand it."

"Trusting to Him who can go with me, and remains with you, and be everywhere for good, let us confidently hope that all will yet be well."

I would like to quote now from Lincoln's Gettysburg Address:

"But, in a large sense, we cannot dedicate, we cannot consecrate, we cannot hallow this ground. The brave men, living and dead who struggled here, have consecrated it far above our poor power to add or to detract. The world will little note nor long remember what we say here, but it can never forget what they did here."

"It is rather for us to be here dedicated to the great task remaining before us; that from these honored dead we take increased devotion to that cause for which they gave the last full measure of devotion."

"That this nation, under God, shall have a new birth of freedom, and that government of the people, by the people, for the people, shall not perish from the earth."

And now, quoting from Lincoln's second Inaugural Address:

"With malice toward none; with charity for all; with firmness in the right, as God gives us to see the right, let us strive on to finish the work we are in; to bind up the nation's wounds; to care for him who shall have borne the battle, and for the widow and his orphan—to do all which may achieve and cherish a just and lasting peace among ourselves and with all nations."

And now this last quotation:

"If I were to try to read, much less answer, all the attacks made on me, this shop might as well be closed for any other business. I do the very best I know how — the very best I can; and I mean to keep doing so until the end. If the end brings me out all right, what is said against me won't amount to anything. If the end brings me out wrong, ten angels swearing I was right would make no difference.

Mr. COFFIN of Cumberland: Mr. President, the name "Abraham" means "father of the multitude" in Hebrew, and no doubt his mother took that from the Old Testament. And in the real sense of the word, he probably can be considered the father of a great many people throughout the world, because there is no country that does not speak of and know of Abraham Lincoln. The majority of our immigrants, if there is any person that they know or think they know, it is Abraham Lincoln.

Abraham Lincoln was born in the most humble of surroundings. Even in his day, the contrast between his mode of living and that of the rest of the country on the eastern seaboard was very great. He was a man that was born to hardship and many disapointments. Early in life he lost his mother. He had less than a year's real schooling as we would know it, and, because of the living conditions and of his father, it was necessary for Abraham to put his shoulder to the wheel and help out with the family expenses.

When still a young man, Anne Rutledge, to whom he was once engaged, died, which was a great disappointment. He knew the bitter taste of defeat in politics.

On becoming President, the secession of the South was already in motion. He was greatly criticised by the members of his own party; even the members of his cabinet were highly invidious. Yet, in spite of all this, Lincoln had a great many qualities to withstand this.

He was first of all considered an honest man in the highest sense of the word. He was a man who had consideration: he had sympathy for nearly everyone. He was a man who was deeply religious. He was strong in his convictions. He also had a most considerable sense of humor, and it was this one quality that probably more than any other saw him through all the discouragements and disappointments that the man had throughout his life. This thing was the one that enabled him to stand up and face men with troubles as great as his own.

I would like to illustrate how he carried on throughout his life, and I am going to speak of an occasion when he and Mr. Douglas were having a debate. Mr. Douglas being a very eloquent speaker, made reference to Lincoln, saying that he could remember when Mr. Lincoln

was selling liquor over the counter in his grocery store. When it came Mr. Lincoln's turn, Mr. Lincoln replied: "What Mr. Douglas says is the truth, and Mr. Douglas was one of my best customers, but what he fails to tell you is that I long ago left my side of the counter but he still steps up to his as tenaciously as ever."

One other time during his presidency, one of his constituents asked him how well he liked the presidency, and Lincoln replied: "It reminds me of the fellow that was tarred and feathered and was being carried out of town on a rail, and one fellow townsman ran alongside and asked the fellow how he liked it, and the fellow replied: 'If it wasn't for the honor of this thing I had just as soon walk.'"

The PRESIDENT: On behalf of the Senate, the Chair extends to Senator Woodcock, Senator Lord and Senator Coffin our deepest appreciation for this fine recognition and tribute to the birthday of one of our truly great Americans. Thank you. (Applause)

Under Orders of the Day the Chair would just mention to the committee chairmen that this morning's schedule of committee hearings was a bit light, and it might be advisable to check your bills to see if you cannot schedule a few additional hearings for Thursday. There seems to be an ample chance for executive sessions. I just pass that long to our Chairmen.
