Mrs. LORD of Cumberland: Mr. President, I would like to inquire if L. D. 636, is in the possession of the Senate?

The PRESIDENT: The Chair will state that it is, having been held at the request of Senator Lord of Cumberland.

Thereupon, on motion by Mrs. Lord of Cumberland, the Senate voted to reconsider its action whereby it referred to the Committee on Towns and Counties, bill, "An Act to Authorize County Commissioners of Cumberland County to Issue Bonds for Portland Bridge Repairs." (L. D. 636); and on further motion by the same Senator, the

bill was referred to the Committee on Highways in non-concurrence. Sent down for concurrence.

On motion by Mr. Cole of Waldo, the Senate voted to take from the table: House Report from the Committee on Transportation, Majority Report "Ought not to pass," Minority report "Ought to pass" on Bill "An Act Relating to License Plates for Disabled or Paraplegic Veterans" which was tabled by that Senator earlier in today's session pending acceptance of either report.

Mr. COLE: Mr. President and members of the Senate: I would like to recall to you attention the fact that the calendar states that the House accepted the Majority Report. This was a printer's error, and it should have been the Minority

Report.

I would like to give the members of the Senate the benefit of the committee's thinking on this particular bill. The bill itself calls for a "V" to be placed before the numerals of a special number plate. The committee, I assure you, have had the greatest amount of respect and consideration for the disabled veterans, the paraplegic veterans. If there had been anything that the committee could have done to improve the situation, I am sure we would have been very glad to have done it.

The present law now in effect gives the veterans a small red tag that can be attached to the regular plates, stating that they are a disabled veteran. It seems to me that this would be much better to assure the public of the due consideration that they desire to give and which the disabled veterans should have rather than to have a "V" before the numerals.

The committee felt that at present we have the "F" before the numeral for farm trucks and an "O" before the numerals for commercial vehicles, beach wagons and so forth. We felt the public would be more responsive to the little plate that is now issued free of charge by the Secretary of State. Another angle is that the present series of our plates do not expire until 1961, and it would seem to me that might be an appropriate time to give this consideration. So I move, Mr. President, that we accept the majority "Ought not to pass" report of the committee.

The motion prevailed and the majority "Ought not to pass" report of the committee was accepted in

non-concurrence.
