## SENATE

Thursday, February 26, 1959

Senate called to order by the President.

Prayer by Rev. John Brett Fort of Bangor.

On motion by Mr. Martin of Kennebec, Journal of yesterday read and approved.

#### Order

On motion by Mr. Woodcock of Penobscot, out of order and under suspension of the rules,

ORDERED, the House concurring, that when the Senate and House adjourn, they adjourn to meet on Tuesday, March 3, at ten o'clock in the forenoon." (S. P. 344)

The PRESIDENT: The Chair notes in the Senate Chamber the presence of two children of one of our members, and at this time would ask the Sergeant - at - Arms to escort Herbert and Susan Charles to the rostrum. (Applause, members rising.)

The PRESIDENT: The Chair also notes in the Senate Chamber the presence of a former distinguished member of this Body accompanied by his wife, and at this time the Chair would ask the Sergeant - at - Arms to escort former Senator Hall and Mrs. Hall to the rost rum. (Applause, members rising.)

Mr. CHARLES: Mr. President and members of the Senate: A short time ago I was approached, after the cloture date, by some constituents of mine in Cumberland County to try to do what I could to introduce a bill that would permit paraplegics to hunt from stationary automobiles. At the present time those who are in this condition are handicapped in enjoying this great outdoor sport in the State of Maine, because of their transportation facilities, in hunting in the woods. These folks are not asking for sympathy in any way whatsoever and very much desire to proceed in regular channels of legislation to be exempted from the rule forbidding them to hunt from stationary automobiles. At this time I present this bill for your consideration.
