SENATE

Friday, March 6, 1959

Senate called to order by the President.

Prayer by Rev. James Waugh of Hallowell.

On motion by Mr. Ross of Sagadahoc, Journal of yesterday read and approved.

The PRESIDENT: At this time the Chair is happy to welcome to the Senate Chamber the parents of the Senator from Cumberland, Senator Charles, and would ask the Sergeant-at-Arms to escort Mr. and Mrs. John Charles to the rostrum. (Applause, members rising.)

On motion by Mr. Woodcock of Penobscot, out of order and under suspension of the rules

ORDERED, the House concurring, that when the Senate and House adjourn, they adjourn to meet on Tuesday, March 10, at ten o'clock in the forenoon. (S. P. 388)

ORDERED, the House concurring, that no bills or resolves shall be transmitted by the Director of Legislative Research pursuant to Joint Order S. P. 47, after 1:00 P.M., March 13, 1959. (S. P. 397)

Mr. WOODCOCK of Penobscot: Mr. President, in connection with this order I would like to give to the Senate a brief progress report of the work of the Legislature to date.

We are now in the 27th legislative day, and as compared to the 27th legislative day of two years ago we have had introduced in the House and Senate together sixteen more bills than we had at this time two years ago: 1164 bills and resolves this session against 1148 two years ago.

On the reports of committees, which I think is a significant statistic, we show a gain of 59 more committee reports that have come to the two branches at the end of the 27th legislative day over what we had two years ago.

Now in the hands of the Director of Legislative Research there are approximately as of this morning twenty-nine Senate bills left to be signed and sixty-four from the House. Now if this order receives passage in the Senate and concurrence in the House that will mean that after 1:00 P.M. next Friday any bill that is not signed at that time is dead for the 99th session of the Maine Legislature. So I urge all of you, for your own best in-terests and the interests of your constituents who are sponsoring these bills to go in there and pick them up by all means before a week from today at one o'clock or they will be dead for this session.

I think that we are showing a reasonably speedy pace at this session compared to two years ago, and if all things go along this way I think we have got a chance of adjourning earlier than two years ago, perhaps in early May. If we all work together and if we can go along with increased speed, I think we can look forward to that. Thank you.

The motion prevailed and the Order received a passage.

Paper from the House State of Maine

In the Year of our Lord One Thousand Nine Hundred and Fiftynine

Joint Resolution

WHEREAS, the State and the Cities and Towns thereof have embarked upon an intensive program of industrial, recreational and agricultural development, and

WHEREAS, a favorable "business climate" is acknowledged to be a major factor in the advancement of such a development program, and

WHEREAS, the success of such a program means more jobs, more payrolls, new sources of revenues and greater prosperity for all our people, and

WHEREAS, the creation and continuance of a favorable "business climate" can only be attained by strict adherence to a set of well defined principles and conditions, and

WHEREAS, these principles and conditions are generally recognized and defined as follows:

- 1. An atmosphere in which the triumvirate of government, management and labor live cooperatively and harmoniously in full recognition of their interdependence and mutual interests:
- 2. A friendly and understanding attitude on the part of government at all levels and a willingness on the part of government, within its proper sphere of activity, to do all within its power to keep Maine industry and commerce in a competitive position;
- 3. An attitude on the part of our people which clearly indicates to industry (both existing and potential) that they are sincerely wanted;
- 4. Careful and prudent planning activities with an eye to present needs and future efficient growth of the state;
- 5. Vigorous community attitudes which reflect concern for continuing and expanding payroll revenues by making more attractive the ease and cost of doing business in this state;
- 6. Sound stable and adequate financial institutions and established machinery for capital generation;
- 7. An informed, intelligent and productive labor force dedicated to pride in product, and which endorses the profit motive as the source of job security and benefits for all; now, therefore, be it

RESOLVED by the Senate and House of Representatives, that the 99th Maine Legislature shall examine all proposed legislation in terms of its effect upon the "favorable business climate" of the state and shall determine whether such legislation may have any deterrent effect upon the business climate of the state, as outlined and be it further

RESOLVED, that copies of this Resolution be transmitted by the Secretary of the Senate to the Governor and the heads of all departments of the State Government with the request that they examine their own discretionary acts in terms of the effect upon the "favorable business climate" of Maine. (H. P. 801)

Mr. HILLMAN of Penobscot: Mr. President, I move that the Senate

concur with the House and I would like to make a few comments.

We in both branches of the legislature are all vitally interested in the development of our great State, industrially and otherwise. A climate that is favorable to business is necessary for growth. I would urge that, for the benefit of existing business and of new enterprise that might be considering coming to Maine, that the 99th Legislature place itself on record as favoring a course of action which will help to create a favorable atmosphere.

This resolution spells out what government should do to attract business to Maine, and it would assure new business prospects the sympathetic cooperation of government.

A resolution such as this would be most welcome to anyone who might be considering Maine as a new home for their enterprise.
