#### SENATE

Thursday, March 12, 1959

Senate called to order by the President.

Prayer by Rev. Alfred H. Ives of Gardiner.

On motion by Mr. Weeks of Cumberland, Journal of yesterday read and approved.

The PRESIDENT: The Chair is pleased to note in the Senate Chamber this morning the attractive wives of two of our colleagues in this Body. At this time the Chair would ask the Sergeant-at-Arms to escort to the rostrum, Mrs. Thurston, wife of the Senator from Oxford, Senator Thurston, and Mrs. Weeks, wife of the Senator from Cumberland, Senator Weeks. A viva voce vote being taken, the motion prevailed and the bill was substituted for the new draft report of the committee. The original bill was given its first reading and tomorrow assigned for second reading.
