SENATE

Thursday, April 2, 1959

Senate called to order by the President.

Prayer by Rev. Malcolm A. Mac-Duffie of Hallowell.

On motion by Mr. HILLMAN of Penobscot.

Journal of yesterday read and approved.

The PRESIDENT: At this time the Chair notes in the Senate Chamber the presence of a former distinguished member of this Body. We are happy to welcome him here this morning and the Chair would ask the Sergeant-at-Arms to escort the Hon. Roscoe Emery of Eastport to the rostrum.

(Applause, members rising.)

Papers from the House Conference Committee Report

The Committee of Conference on the disagreeing action of the two branches of the Legislature on Bill, "An Act Relating to License Plates for Disabled or Paraplegic Veterans." (H. P. 229) (L. D. 319) reported that they are unable to agree.

Comes from the House, report accepted.

In the Senate, the report was accepted in concurrence.

Bill, "An Act Relating to Quinellas at Harness Race Meets." (H. P. 70) (L. D. 108)

In Senate on March 13, passed to be engrossed as amended by Committee Amendment A (Filing No. 56) in concurrence.

Mr. COFFIN: Mr. President and ladies and gentlemen: As you know, I am a member of the Sea and Shore Fisheries Committee, and for some reason or other I have made a few friends down on the coast here and yesterday they showed up here with half a bushel of clams and several pounds of lobsters. They had heard through the grapevine that I wanted to put on a chowder for the Senate. I had not intended to do it this

week. However, with the ingredients so expensive and they being given to me, I think it will be necessary for me to do this tomorrow. I would say also that this is due to the fact that my good friend, the Senator from Hancock, Senator Pierce, induced someone to give us the bowls.

I am not going to give you a fullscale dinner tomorrow, but I am going to give you all the chowder you would like to eat as well as

crackers and pickles.

This will be done down in Room 228 on the second floor between the hours of 11:30 and 12:30. I also invite all of the officials who are connected with the Senate. Thank you.

The PRESIDENT: The Chair believes that the applause accompanying the remarks of the Senator from Cumberland, Senator Coffin, indicates the universal acceptance of his offer, and the Chair predicts that all of us will be present tomorrow.

On motion by Mr. Carpenter of Somerset, the Senate voted to take from the table the 31st tabled and unassigned matter, (H. P. 630) (L. D. 922) Bill, "An Act Prohibiting Signature or Countersignature by Rubber Stamp or Other Facsimile," which was tabled by that Senator on March 20th pending passage to be engrossed.

The same Senator then presented Senate Amendment "A" and moved its adoption.

Senate Amendment "A" was read by the Secretary and adopted and the bill was passed to be engrossed as amended in non-concurrence.

On motion by Mr. Boucher of Androscoggin, the Senate voted to take from the table the 12th tabled and unassigned matter, (S. P. 28) (L. D. 8) Bill, "An Act Relating to Definition of Liquor Under Liquor Laws," which was tabled by that Senator on March 11th pending enactment; and on further motion by the same Senator the bill was passed to be enacted.

On motion by Mr. Boucher of Androscoggin, the Senate voted to take from the table the 16th tabled and unassigned matter, (H. P. 324) (L. D. 471) Bill, "An Act Relating to County Parking Areas," which was tabled by that Senator on March 12th pending enactment; and on further motion by the same Senator the bill was passed to be enacted.
