#### SENATE

Wednesday, April 8, 1959

Senate called to order by the President.

Prayer by Rev. Albert B. Reynolds, of Freeport.

On motion by Mr. MacDonald of Oxford,

Journal of yesterday read and approved.

The PRESIDENT: At this time the Chair would like to welcome to the Senate Chamber a group of students from the Milford Grammar School accompanied by Mr. Lionel Alley. It is a real pleasure to have you young people with us this morning. We trust that the day will be educational and enjoyable and I am sure that every Senator joins with me in welcoming you here to what we hope will be a fine day for you.

#### Papers from the House

Bill, "An Act Relating to Definition of Tavern Under Liquor Laws." (H. P. 695) (L. D. 995)

In Senate on April 3, Indefinitely Postponed in non-concurrence.

Comes from the House, that body having Insisted upon its former action whereby it accepted the Majority Report (Ought to pass) from the Committee on Liquor Control and passed the bill to be engrossed. In the Senate:

Mr. FARLEY of York: Mr. President, I move that the Senate insist and ask for a committee of conference.

Mr. BOUCHER of Androscoggin: Mr. President, I move that the Senate recede and concur.

Mr. FARLEY of York: Mr. President, when the vote is taken I ask for a division.

The PRESIDENT: The question is on the motion of the Senator from Androscoggin, Senator Boucher to recede and concur and a division has been requested.

A division of the Senate was had.

Four having voted in the affirmative and twenty-two opposed, the motion did not prevail.

Thereupon, the Senate voted to insist on its former action and request a committee of conference. The President appointed as Senate members of such committee, Senators: Farley of York, Cole of Waldo and Willey of Hancock.

#### Orders of the Day

Mr. COLE of Waldo: Mr. President, may I inquire if L. D. 1098, Bill, "An Act Relating to Inspection of Motor Vehicles" is in the possession of the Senate.

The PRESIDENT: It is, having been held at the request of the Senator from Waldo, Senator Cole.

On motion by Mr. Cole of Waldo, the Senate voted to reconsider its former action whereby the bill was passed to be engrossed and the same Senator presented Senate Amendment A and moved its adoption.

Mrs. LORD of Cumberland: Mr. President, may I inquire if L. D. 1120 is in the possession of the Senate?

The PRESIDENT: It is, having been held at the request of the Senator from Cumberland, Senator Lord.

On motion by Mrs. Lord of Cumberland, the Senate voted to reconsider its former action whereby it indefinitely postponed, "Resolve to Reimburse the City of Portland for Support of Joseph A. and Madelon E. Glidden."

Mrs. LORD of Cumberland: Mr. President and members of the Senate, information given to the City of Portland in 1955 pertaining to the parents of Joseph A. Glidden and the custody of said Joseph A. Glidden, the City of Portland furnished relief to said Glidden for 1955-56 and 1957. It was not until 1959 did the city of Portland learn for the first time that Joseph A. Glidden was not given into the custody of his mother in 1943.

Joseph A. Glidden became of age Dec. 23, 1954 with an unsettled status derived from his father. The State Department of Health and Welfare has now accepted Joseph A. Glidden as an unsettled status. The State Department of Health and Welfare does not have the funds in its budget at this time to pay the City of Portland \$1,388.61. I understand since then the Welfare Department has paid a sum something around \$144 to the City of Portland.

Therefore, Mr. President, I move that this bill be passed.

The PRESIDENT: The question before the Senate is on the motion of the Senator from Cumberland, Senator Lord that the Senate accept the Minority "Ought to pass" report of the Committee.

Mr. PARKER of Piscataquis: Mr. President, I am not at this time prepared to defend the action of the committee on this bill because I do not have the notes that were taken at the time of the hearing, but I would like to place this on the table and I assure you I will get that information and take it off just as soon as I can. So I would like to table this bill.

The motion prevailed and the resolve was laid upon the table pending motion by Mrs. Lord of Cumberland to accept the Minority ought to pass report.

The PRESIDENT: At this time the Chair would like to recognize in the Senate Chamber the members of the eighth grade from St. Patrick's School in Lewiston, accompanied by their teachers, Sister Saint John and Sister Saint Paula. It is certainly a pleasure on behalf of the Senate to welcome you students and sisters here this morning. We hope you will enjoy your day and will find it educational as well as enjoyable. On behalf of the Senate, the Chair most cordially welcomes all of you.

Mr. LESSARD of Androscoggin: Mr. President, I request unanimous consent to address the Senate.

The PRESIDENT: The Chair hears no objection, and provided he is able to carry out his request, the Senator may proceed.

Mr. LESSARD: Mr. President, I apologize for my laryngitis.

At the outset I would like to state that accompanying these lovely children from St. Patrick's also is the brother-in-law of our fine Secretary, Victor Lageux of Lewiston.

However, that is not my purpose in arising this morning. My real purpose, as some of you probably know, is to tell you that during this past year we in Lewiston and Auburn and Central Maine have constructed at our Youth Center a very fine ice rink. This Sunday marks our last hockey game of the season, and the directors of the rink have asked me on behalf of the Senate to invite the members of the Senate and the Senate staff to be their guests next Sunday afternoon at two o'clock. The game is to be played between a team from St. Hyacinthe, Quebec, one of the top teams in the Province of Quebec, and the Bates Fabric Team which represents Bates Manufacturing Company. So if any of the members of the Senate and its staff can be in attendance at the game next Sunday, starting at two o'clock, you will have an opportunity to see our rink, of which we are very proud. If you will leave your name with the Secretary in his office I will see that the tickets are here tomorrow for distribution. (Applause)

The PRESIDENT: The Chair thanks the Senator from Androscoggin, Senator Lessard, for his kind invitation to the members of the Senate to attend the hockey game next Sunday at two o'clock, and the Chair is certain that as many of us as possible will like to avail themselves of the invitation. The Chair also thanks the Senator from Androscoggin for recognizing the fact that we have other distinguished visitors here this morning. The Chair welcomes you folks from Androscoggin County.
