### Orders of the Day

Mr. Charles of Cumberland was granted unanimous consent to ad-

dress the Senate.

Mr. CHARLES: Mr. President and members of the Senate: I have two orders which I am going to present this morning but I am going to take them up individually. Both of them have to do with Legislative Research Committee studies. The first one I would like to discuss is a study relative to Mo-bile Banking, the bill for which was presented by the Senator from Thurston. Oxford. Senator The Committee on Business Legislation took this very seriously and found require a considerable amount of research study as to its impact upon the banking system of our State. Therefore, with mutual understanding, we assured the sponsors of this bill that we would do the best we could in committee to try to refer this matter to the Legislative Research Committee, For this reason, I present an order and move its passage.

The Order was read by the Sec-

retary as follows:

ORDERED, the House concur-

ring:

the Legislative Research Committee be and hereby is authorized and directed to study Mobile Banking for the purpose of determining community needs for mobile banking services in the State and the impact of furnishing such services upon the present banking operations, practices and procedures.

And be it further ordered that the committee report the results of its study to the 100th Legislature.

On motion by Mr. Woodcock of Penobscot, the order was tabled pending motion by Mr. Charles of Cumberland that the order receive

Mr. CHARLES of Cumberland: Mr. President and members of the Senate: The Committee on Business Legislation also had under consideration another bill which they desire very much to refer to the Legislative Research Committee. This has to do with L. D. 1218, Bill, "An Act Relating to Licensing of Home Party Plan Demonstrators." The committee also studied this bill and found it had merit for further consideration, and it desires very much to introduce this order for futher consideration. I therefore present this order and move its passage.

The order was read by the Secre-

tary as follows:

ORDERED, the House concurring, that the Legislative Research Committee be and hereby is authorized and directed to study the need for state licensing and regulation of Merchandise Club Demonstrators who solicit orders or make contracts for merchandise sold or supplied by persons or organiza-tions having no regular place of business within the State;

And be it further ordered that the committee report the results of its study to the 100th Legislature. On motion by Mr. Woodcock of Penobscot, the order was tabled

pending passage.

The PRESIDENT: At this time the Chair would like to welcome to the Senate Chamber this morning members of the Harmony High School of Harmony, Maine, accompanied by instructors Mr. Jackins and Mr. Chadbourne. On behalf of the Maine Senate we extend a very hearty and cordial welcome to you young people. We hope that you will enjoy your observations here in the capital today, and I am sure that each and every senator will do his and her utmost to make it a pleasant and educational day for you. (Applause)

On motion by Mr. Charles of Cumberland, the Senate voted to take from the table (S. P. 364) (L. D. 1047) Bill, "An Act Relating to Certification by Automobile Deal-

ers of Mileage of Used Motor Vehicles," which was tabled by that Senator on April 10th pending consideration.

Mr. CHARLES: Mr. President, I yield to the Senator from Aroostook, Senator Rogerson.

Mr. ROGERSON of Aroostook: Mr. President, this measure was one which was directed towards correcting the common evil which is practiced by automobile dealers, setting back of automobile speedometers. This has had rather a stormy passage, if that is not a misuse of the word, up to this point. It met an untimely end in the other branch and we were able to breathe some life back into it, but again it has struck an obstacle which indicates that this sort of law is not timely. I therefore move the pending question.

The PRESIDENT: The Secretary will read the endorsements on the

The SECRETARY: "In the Senate on April 1st, passed to be engrossed. In the House on April 9th, bill indefinitely postponed in non-concurrence and the motion to reconsider lost."

On motion by Mr. Rogerson of Aroostook, the Senate voted to recede and concur with the House.

Mr. MARTIN of Kennebec: Mr. President, it is my understanding that the Senator from Oxford, Senator MacDonald, wishes to present an amendment and in order that he may do so, I now move that the Senate accept Report A "Ought to Pass".

The motion prevailed, Report A was accepted and the bill read

Mr. MacDonald of Oxford presented Senate Amendment A and moved its adoption.

Which amendment was read and adopted and the bill as amended was tomorrow assigned for second reading.

On motion by Mr. Weeks of Cumberland, the Senate voted to take from the table Senate Report from the Committee on Judiciary "Ought not to pass" on Bill, Changing Name of Norway Municipal Court to Norway-Paris Municipal Court and Its Location" (S. P. (L. D. 908) tabled by that Senator on April 3 pending acceptance of the report; and that Senator yielded to the Senator from Oxford, Senator MacDonald.

On motion by Mr. Martin of Kennebec, the Senate voted to take from the table Senate Report from the Committee on Judiciary "Ought not to pass" on Bill, "An Act Re-lating to Penalties for Certain Crimes Against the Person." (S. P. 378) (L. D. 1104) tabled by that Senator on April 3 pending acceptance of the report; and on further motion by the same Senator, the "Ought not to pass" report was accepted.

On motion by Mr. Willey of Hancock, the Senate voted to take from the table House Report from the Committee on Taxation "Ought not to pass" on Bill, "An Act Exempting Hospital Thrift Shops from Sales Tax." (H. P. 700) (L. D. 1000) tabled by that Senator on April 7 pending acceptance of the report; and that Senator yielded to the Senator from Washington, Senator Wyman.

Mr. WYMAN of Washington: Mr. President and members of the Senate: Your joint committee on Taxation heard this bill and reported it unanimously "Ought not to pass." According to the best information we could get, the bill was introduced because of an unusual situation in one of our municipalities which has a hospital thrift shop. In this case the thrift shop purchased the entire stock of a shopkeeper and when representatives of the Sales Tax Division visited the shop for a routine check they found management, in the new cordance with law, collecting the sales tax on merchandise sold.

At the hearing we asked the proponents of the bill if they felt the thrift shops were losing any sales on account of this tax and the answer was an unqualified no, but they stated that it was a nuisance to collect.

Now, members of the Senate, I ask you: Are we going to exempt this special group? If this bill is passed not one cent of the tax revenue lost will go to help hospitals, and, by their own admission, they will not sell any more merchandise. Therefore I move the indefinite postponement of the bill and accompanying papers.

Mr. ROSS of Sagadahoc: Mr. President, before we vote on indefinite postponement I have two or three questions I would like to ask through the Chair, of the Senator who just spoke on this matter.

My first question is: How many hospital thrift shops are there in the State? My second question is: How much tax do we collect at the present time.

The PRESIDENT: The Senator from Sagadahoc, Senator Ross, proposes two questions of the Senator from Washington, Senator Wyman. The Senator from Washington, Senator Wyman, may answer if he chooses.

Mr. WYMAN: Mr. President, the first question I cannot answer, and neither can I answer the second one in full. I do know this hospital thrift shop did some fourteen thousand dollars worth of business in less than two years, that they were advertising merchandise for sale not only in their shop but on other premises and directing purchasers there. In other words, they were doing a rather substantial business.

It was like the bill we had two years ago to exempt sales of the American Flag, which certainly was a minor matter; but all of these minor exemptions add up over a period of years to a considerable sum.

Mr. ROSS of Sagadahoc: Mr. President, until I can really find the answers to these two questions, and since I think one of these thrift shops is in my community, I would beg the indulgence of my good friend, the Senator from Washington, Senator Wyman, and move that this item be placed on the table.

The motion prevailed and the bill was tabled pending motion of Mr. Wyman of Washington that the bill and accompanying papers be indefinitely postponed.

Adjourned until ten o'clock tomorrow.
