SENATE

Monday, May 4, 1959

Senate called to order by the President.

Prayer by Rev. Henry Webber of South Gardiner.

On motion by Mr. Hunt of Kennebec,

Journal of last Friday read and approved.

Papers from the House

"Resolve to Reimburse the City of Portland for Support of Joseph A. and Madelon E. Glidden." (H. P. 788) (L. D. 1120)

In Senate on April 30, passed to be engrossed in non-concurrence.

Comes from House, that body having ADHERED to its former action whereby the resolve was Indefinitely Postponed.

In the Senate, on motion by Mrs. Lord of Cumberland, the Senate voted to insist and ask for a committee of conference; the President appointed as Senate members of such committee, Senators: Lord of Cumberland, Weeks of Cumberland and Charles of Cumberland.
