#### Orders of the Day

Mr. Dow of Lincoln was granted unanimous consent to address the Senate.

Mr. DOW of Lincoln: Mr. President and members of the Senate: It is my sincere hope that all of the members of this Senate will weigh and weigh carefully all the serious problems that we are faced with in our educational structure statewide and until all of the facts have been presented. I have been dismayed in the past by a feeling that opinions were formed and commitments made, though honest and sincere, before the final presentation of both sides of controversial issues. Let us not trade horses or play politics with the destinies of our children, but, instead use our be st individual sound judgment, which, in my opinion cannot be conclusively and justly formed by haste or gestures of personal compatibility.

The PRESIDENT: The Chair thanks the Senator from Lincoln, Senator Dow, for his remarks and we certainly will consider them.

Mr. WOODCOCK of Penobscot: Before reading the adjournment order I would like to urge each committee chairman to call his committee into executive session if the need is there, unless otherwise occupied. I think if we adopt the policy of using all deliberate speed we can point to an adjournment sometime late next week. Quite a lot of it, of course, depends on the timing of the committee reports.
