LD 652 / HP0502

Original Title: Resolution, Proposing an Amendment to the Constitution of Maine to Change the Municipal Tax Loss Reimbursement Formula, to Change the Penalty for the Withdrawal of Land from Current Use Valuation and to Require a Two-thirds Vote for the Expenditure of Funds from the Mining Excise Tax Trust Fund. New Title: Resolution, Proposing Amendments to the Constitution of Maine to Change the Municipal Property Tax Loss Reimbursement Formula, to Change the Penalty for the Change of Use of Land Subject to Current Use Valuation and to Require a Two-thirds Vote for the Expenditure of Funds from the Mining Excise Tax Trust Fund. (Reported Pursuant to Study Order, Public Laws, Chapter 711 of the 110th Legislature.) Taxation Hearing 4-5-83. Majority OTP-AM Accepted (Minority O.N.T.P.). Amended by: CA (Changed Title) H-317, HA/CA H-331. Finally Passed, 6-21-83, CON RES LAWS, Chapter 2. Question 1 ("Shall the Constitution be Amended to Change the Municipal Property Tax Loss Reimbursement Provisions and to Change the Penalty Payable Upon the Change of Use of Land Containing Minerals which is being Valued at Current Use?") Approved in Referendum, 11-8-83 (In favor: 140,680; Opposed: 125,309); Question 2 ("Shall the Constitution of Maine be Amended to Require Two-thirds Vote of the Elected Members of the Legislature to Expend Any Principal Amount of the Mining Excise Tax Trust Fund or Any Successor Funds?") Approved in Referendum, 11-8-83 (In favor: 179,082; Opposed: 96,370).
